The property is located at Rocky Ledge Swim Club, 1402 Old Orchard Street and known on the North Castle Tax Maps as Section 3, Block 74, Lot 1.H and located within the R-1A Zoning District.

Marc Mancini, the applicant, appeared before the Board with his wife Amy Mancini, to request the Board's approval to hold a Halloween event during the last three weekends of October. Mr. Mancini said the event would consist of activities, including face painting and pumpkin painting, for young children from 1 p.m. to 3 p.m. on Friday, Saturday and Sunday. Activities for older children and adults, including a graveyard and haunted house and corn mazes, would be scheduled from 8 p.m. to 11 p.m. on Friday and Saturday and from 7 p.m. to 10 p.m. on Sunday. Mr. Mancini said he had met with Lt. Simonsen who walked the site with him.

Director of Planning Kaufman said the applicant is required to have a police officer on site and a fire watch by the North White Plains Fire Department or the Town's Fire Marshal. Mr. Kaufman said the plans and related documentation were sent to the Police Department, Fire Department and the Fire Marshal for their recommendations. Per Town Code, the areas to be used for the special event cannot be within 250 feet of any residential property. Mr. Kaufman said the applicant had provided a schematic of the property survey and has designated the locations of the areas to be used, but since the schematic was not prepared by a professional and the distances have not been included and therefore could not be verified.

Mabel Davidson, 1448 Old Orchard Street read aloud a letter in which she and her husband expressed their opposition to the event, citing concerns about noise and adequate parking.

Lisa Dorfman, Memorial Lane, expressed her opposition and her concern about increased traffic on narrow roads in White Plains which she said are in very bad condition.

Mario Ruggiero, Limestone Road, said he was not opposed to the event, adding that some of the problems being cited were not related to the event.

In response to an inquiry from Joe Fontanella, 1450 Old Orchard Street, on how the number of attendees would be limited to 200, Councilman Kittredge said a police officer would be at the site to control traffic and ensure people did not park on streets where parking is not permitted. Councilman Roth suggested that a method be devised to determine the number of attendees. Mrs. Mancini said she had experience in recreational events and would work out a plan for a staff member to handle this.

Councilman Kittredge recommended that the Building Department do a walk through prior to the start of the event and schedule a meeting after the first weekend of the event with the applicant and the Police and Building Departments, to insure that there are no problems.

In response to an inquiry from Trish Fontanella, about how noise from sound effects and the crowd would be controlled, Mr. Mancini said he would try to muffle the sounds.

Grace Sorrentino, Old Orchard Street, who lives a short distance from the swim club, said her barn has been vandalized and asked why the location was selected. Mr. Mancini said it provided the open space and the parking needed.

Steven O'Connor, Round House Court, recommended that access to the property be controlled, backpacks be checked, more than one police officer be on site, and that the Town ensure the applicant has the appropriate insurance.

Councilman Roth confirmed with Town Attorney Baroni that the event could be stopped if it did not go well.

Tony Futia, Custis Avenue, said that he thought the site was fenced on all sides and people would need to enter through the gate. Mrs. Davidson reported that despite fencing, she has called the Police Department to report that teens had entered the pool at night,

Sara Doto, Hobby Lane, said she sympathized with the residents and suggested there be a compromise and the event take place on one or two days.

Mr. Mancini said he lives in the neighborhood and planned to hold an event which would not cause problems for his neighbors. He said it would not be cost effective to hold the event for a short period of time. He added that he would ensure that all attendees would exit the site by midnight on Friday and Saturday nights.

Councilman Schiliro said there were many regulations in place to ensure the event would operate within the parameters of Town Code.

Councilman Cronin expressed his concern that the event would take place in a residential neighborhood and said it was not of value to the Quarry Heights residents.

The Board requested that Mr. Kaufman modify the first condition in the resolution to exclude the requirement that an exhibit, demonstrating any area to be used for special events not be located within 250 feet to an existing residential footprint, must be prepared by a qualified professional. The Board asked Mr. Kaufman to review the exhibit to be submitted by the applicant demonstrating that any area to be used meets the required setbacks and that Mr. Kaufman work with the applicant to ensure the requirements are met to the satisfaction of the Planning Department.

No other correspondence or comments were entered for the record.

After all persons were heard who desired to be heard, Councilman Kittredge moved, seconded by Councilman Schiliro, that the public hearing be closed at 9:05 p.m.

WHEREAS, an application dated August 11, 2010 was submitted by Haunted Dead End to operate a special event at the Rocky Ledge Swim Club pursuant to Chapter 83 of the Town Code; and

WHEREAS, Haunted Dead End is requesting permission to conduct a Halloween special event that is open to the public and will hold not more than 200 people, at any one time, on Fridays, Saturdays and Sundays during the month of October; and

WHEREAS, activities will include a late afternoon/early evening family event that includes face painting, pumpkin painting and Disney characters and an evening adult/teen event that includes a graveyard, vortex tunnel, corn maze and haunted house maze; and

WHEREAS, the operation of the special event would not require any permanent construction; and

WHEREAS, the site plan was forwarded to the Chief of Police, Fire Inspector and the North White Plains Fire Chief so that they may make any pertinent recommendations to the Town

Board including, but not limited to, the designation of no-parking zones, emergency vehicle access or any other issues deemed important to providing emergency services; and

WHEREAS, the application was referred to the Westchester County Planning Board pursuant to § 239-m of New York State General Municipal Law (GML) on August 20, 2010; and

WHEREAS, the 14-acre property is located in the R-1A Zoning District and is designated on the Tax Maps of the Town of North Castle as Section 3, Block 14, Lot 1.H; and

WHEREAS, a duly advertised public hearing was held on said application before the Town Board on September 7, 2010 and closed on that date at which time all those wishing to be heard were given the opportunity to be heard; and

WHEREAS, the notice of public hearing was sent to the City of White Plains City Clerk and the Town Clerk of the Town/Village of Harrison pursuant to § 239-nn of New York State General Municipal Law (GML) since the subject site is located within 500 feet of the City of White Plains and the Town/Village of Harrison; and

WHEREAS, the Town Board is familiar with the nature of the site and surrounding area;

WHEREAS, the Town Board has requested, received and considered comments from the Town Attorney, the Town Engineer and Town Planner regarding the proposed special event; and

WHEREAS, the proposed action is an Unlisted Action pursuant to the State Environmental Quality Review Act (SEQRA); and

WHEREAS, the Town Board determined to conduct an uncoordinated SEQRA Review; and

NOW, THEREFORE, BE IT RESOLVED, that in accordance with Article 8 of the New York State Environmental Quality Review Law and 6 NYCRR Part 617 and the North Castle Environmental Quality Review Law, the Town Board hereby makes a determination that the proposed action will not have a significant adverse impact on the environment and that a draft environmental impact statement will not be prepared; and

BE IT FURTHER RESOLVED, that the special event permit is approved for a term beginning October 15, 2010 and ending October 31, 2010, for a total of nine days, subject to the conditions identified below; and

BE IT FURTHER RESOLVED, that this permit shall be deemed to authorize only the particular use or uses specified, and shall expire if the site is not maintained and if all conditions and standards are not complied with throughout the duration of the use; and

Prior to the Issuance of the Special Event Permit:

(The Town Clerk's initials and date shall be placed in the space below to indicate that the condition has been satisfied.)

- _____ 1. Pursuant to Section 83-3.C of the Town Code, the Applicant shall submit an exhibit demonstrating that any area to be used for special event purposes is not be located closer than 250 feet to an existing residential house footprint to the satisfaction of the Planning Department.
- _____ 2. Pursuant to Section 83-3.D of the Town Code, the Applicant shall provide documentation confirming that bathroom facilities are provided that are accessible, and adequate in number, to satisfy the needs of patrons of the special event to the satisfaction of the Building Inspector.
- _____ 3. Pursuant to Section 83-4.D of the Town Code, the Applicant is required to submit plans showing the layout of the event area, including the location of all existing structures and improvements, the location and description of all event-related temporary structures, tents, stands, ingress and egress, parking, signs, lighting, electrical equipment, sound equipment, mechanical equipment, portable toilets.

At a minimum, the plan shall contain the following information to the satisfaction of the Planning and Building Departments:

- a. Plan that depicts the footprints of all residential structures in the vicinity of the property.
 - b. Plan that depicts the layout (or description) of the proposed corn maze as well as layout (or description) of activities that are proposed in the open fields, basketball court, handball court, covered porch and picnic shelter.
 - c. Plan that depicts all existing and proposed lighting. At a minimum, it is recommended that emergency lighting of the entire special event area should be provided. In addition, adequate lighting shall be provided in and around the food, restroom and office area. Furthermore, the plans shall demonstrate that adequate lighting is provided in the parking area.
 - d. Width of all pathways
 - e. Plan that depicts all property lines
- _____4. Revision of the plans addressing any written comments received from the Police, Fire and Building Departments to the satisfaction of the Planning Department.
- _____5. Pursuant to Section 83-4.F of the Town Code, a certificate of insurance from an insurance company licensed to do business in New York State with the following minimum coverages to the satisfaction of the Town Clerk:
- (1) Bodily injury: \$300,000, one person.
 - (2) Bodily injury: \$1,000,000, one accident.
 - (3) Property damage: \$100,000, one accident.
- In addition, the Town shall be identified as additionally insured to the satisfaction of the Town Attorney.
- _____6. Pursuant to Section 83-4.G of the Town Code, the Applicant shall submit all documentation demonstrating approval from the Westchester County Department of Health to the satisfaction of the Building Department.
- _____7. Pursuant to Section 83-4.I of the Town Code, the Applicant shall post a cash bond of \$500 to guarantee cleanup by the exhibitor after the special event, except where the special event is conducted on premises owned by the person making the application.

Other Conditions:

1. Pursuant to Section 83-3.A of the Town Code, all special events shall require the provision of a "fire watch" by the local Fire Department and/or North Castle Fire Marshal, the cost of which shall be paid for by the applicant. The Fire Marshal may also approve other fire-protection measures to the satisfaction of the North Castle Fire Marshal, the cost of which shall be paid for by the applicant.
2. Pursuant to Section 83-3.B of the Town Code, all special events shall require the provision of security and/or traffic control by the Town of North Castle Police Department, the cost of which shall be paid for by the applicant. The Chief of Police may also approve other security and/or traffic control measures to the satisfaction of the Chief of Police, the cost of which shall be paid for by the applicant.
3. This special event permit is not assignable.

4. This special event permit is revocable for a violation of the Town Code or any other ordinance or law, pursuant to Chapter 83-6 of the Town Code.
5. The Applicant shall observe all state, county and Town laws, rules and regulations as to health, safety and general welfare and shall be subject to reasonable regulations of the Building Department, Fire Marshal, Police Department and Highway Department of the Town of North Castle.
6. The special event shall not be conducted prior to 10:00 a.m. or after 12:00 midnight.
7. All rubbish from the premises and from any parking area must be gathered and deposited in closed containers by no later than 6:00 p.m. of the day following and removed from the premises by 6:00 p.m. of the next day following.
8. The Applicant shall not permit any unnecessary or unreasonable noise by means of loudspeakers, power amplifier devices or any other means which would create or tend to create a public nuisance.
