

Specifications may be obtained at the Highway Office at 17 Bedford Road, Armonk, NY, on any business day. Bidder is required to submit a non-collusion statement at the time of bidding.

INSTRUCTIONS AND GENERAL CONDITIONS

1. Each bid must be in a sealed envelope and addressed to
Alison Simon, Town Clerk, Town of North Castle, 15 Bedford Rd.
Armonk, New York 10504.
2. Each bid shall have endorsed on the envelope the name and address of bidder, date, time and subject of bid opening. In order to be valid, all bids must be properly signed and received by the town by the time and date specified.
3. Each bid must have a completely executed Non-Collusion Certificate attached to same.
4. Each bid must be accompanied by bid security in the form of a bid bond or certified check payable to the Town of North Castle in the amount of not less than 5% of bid, if applicable.
5. All bids must be priced per unit specified in the bid specifications. Quotation to be indicated on bid forms supplied by Town.
6. The Town reserves the right to reject any or all bids or any portion thereof.
7. Any deviation from specifications shall be clearly stated and fully explained by accompanying circulars and specification sheets. The town reserves the right to accept approved equals.
8. Purchases by the Town are NOT SUBJECT to any Federal, State or Local Taxes. Exemption Certificate will be furnished upon request.
9. Failure to deliver within the specified time may be cause of cancellation of the order and/or removal of bidder's name from bidder's list.
10. All deliveries are to be made to the Town of North Castle Garage.
11. The bid shall be signed by a duly authorized person representing either a corporation, unincorporated business or a partnership.
12. All items furnished under bid shall be delivered and erected under fully warranty for a minimum of 12 months on unit and all related equipment. If, during this period, repairs and/or replacement or assemblies become necessary, such repairs and replacements shall be made or caused to be made by the contractor at no cost to the Town of North Castle.

ITEM #1 – PRECAST CONCRETE STRUCTURES

Scope

Under this item, the supplier shall supply precast concrete structures including catch basins and drain inlets. Also, the supplier shall supply heavy duty frames and grates.

All precast structures shall be capable of withstanding HS-20-44 loadings.

Material

All structures shall be precast, consisting of Portland cement, mineral aggregates and water at the proper ratios, with steel reinforcement. Precast sections shall be manufactured in accordance with ASTM Designation C478-67T. The minimum compressive strength of the concrete for all sections shall be 4,000 psi at 28 days.

The cement shall meet, with exception of gradation requirements, with the Specifications for concrete aggregates (ASTM Designation C33).

All catch basins shall consist of a rectangular base section with inside dimensions equal to 30 inches by 48 inches and a height as specified below. Wall and slab thickness shall be a minimum of six (6) inches.

All drain inlets shall consist of a square base section with inside dimensions equal to 30 inches by 30 inches and a height as specified below. Wall and slab thickness shall be a minimum of six (6) inches.

Item 1DI-S3	3' Depth With Sump
Item 1DI-NS4	4' Depth Without Sump

Openings within the structure walls shall be knock outs to the dimensions and pipe diameters provided by the Town.

Structure shall be constructed with and without sumps as specified by the Town. Sumps shall be a minimum depth of 18 inches when required.

Steps:

Steps shall be provided in catch basins in excess of four (4) feet in depth and shall be steel reinforced polypropylene drop front type.

Frames and Grates:

All frames and grates shall be a heavy duty casting, Pattern Number 2617 with bicycle safe grate as manufactured by Campbell Foundry or approved equal for catch basins and Pattern Number 2816 for drain inlets.

Alternate Frames and Grates:

All frames and grates shall be heavy duty load bearing produced from Gray Cast Iron to ASTM A48, Class 35, as manufactured by Sigma or approved equal, and use special process controls and continuous testing to ensure the consistency of the higher grade material. Each casting shall be produced with a cast heat code, bearing the foundry ID and date/month/year code, to ensure complete traceability. All frames and grates shall be load tested per sampling plan, using a hydraulic load tester to ensure compliance with H-20 and AASHTO M-306 load test specifications. All casting shall be produced in foundries with ISO-9000 quality certification.
