### APPENDIX A

The facilities listed on the register obtained from the New York State Office of Information Technology Services (the "Registry") for the towns of Bedford, Mount Pleasant, New Castle, North Castle and Pound Ridge contain a wide range of human services programs, not all of which are classified as residential. They range from the New York State prison for women at Bedford Hills, the Westchester County Correctional facility, Westchester County Medical Center, the Westchester Runaway Youth Shelter, juvenile detention facilities as well as community residential facilities for mentally ill, developmentally disabled and substance abusers. They include programs that serve the following populations:

- Mentally ill
- Substance abusers
- Developmentally disabled
- Medically ill children
- Medically Ill adults
- Juvenile delinquents
- Criminal detainees and sentenced offenders

Accordingly, under the provisions of the Padavan Law and governing case law, the Registry is overinclusive to the extent it includes such hospitals, jails, nursing homes, outpatient facilities, and other non-residential facilities, and Paradigm does not concede their relevance. Furthermore, the list forwarded from the Registry is also over-inclusive to the extent that it includes facilities from several neighboring townships, as well as the entire Town of North Castle, and the relevant area or community for purposes of Padavan analysis is the area "in proximity to" the Cole Drive location (see MHL section 41.34 (c) (1) (C)), and Paradigm does not concede the relevance of residences outside of the area proximate to the Cole Drive location.
