RE: Paradigm Treatment Centers LLC Establishment of a Community Residential Facility for the Disabled by Paradigm Treatment Centers LLC at 14-16 Cole Drive in the Town of North Castle, New York (the "Site")

Dear Supervisor Schiliro:

We represent Paradigm Treatment Centers LLC ("Paradigm" or the "Sponsoring Agency"), a provider of treatment programs for those suffering primarily from mental illness, including depression, anxiety, trauma and grief.

We respectfully submit this letter as a supplement to Paradigm's letter delivered November 9, 2016 (the "Paradigm Letter") to the Town of North Castle (the "Town") pursuant to New York Mental Hygiene Law Section 41.34, otherwise known as the "Padavan Law", to advise you that Paradigm intends to operate a community residential facility for the disabled at the above-referenced Site (the "Community Residence").

As more fully discussed in the Paradigm Letter and below, the Community Residence would be licensed by the New York State Office of Mental Health ("OMH"), would provide housing, supervision and a residential treatment program for up to eight (8) adolescent individuals suffering from mental illness, and would operate within the existing structures on the Site.

All admissions to Paradigm's program will come through the Single Point of Access (SPOA) process administered by the Westchester County Department of Community Mental Health Services, where the highest priority would be given to residents of Armonk, then Westchester County and then the rest of New York State. Only then would residents from outside of New York State be considered. Given Paradigm's current census in California,

where one third (1/3) of all residents are from New York, it is doubtful that the proposed program would be able to accommodate many residents from outside of New York State. Paradigm's decision to develop a program in New York was in response to the feedback from New York families seeking more local treatment for their sons and daughters.

I. Applicability of Local Zoning Regulations

The proposed Community Residence is located in the Town's R2-A zoning district. Pursuant to Section 355-21, "single-family dwelling units, not to exceed 1 on any lot" are a permitted, as of right, principal use in the Town's R2-A zoning district.

As acknowledged in the letters sent to the Town by Joshua J. Grauer, Esq. dated November 28, 2016 and November 29, 2016 (collectively, the "Grauer Letter"), the long-standing purpose of the Padavan Law is to promote the deinstitutionalization of mentally disabled residents and to allow for the establishment of group homes in local communities.

Under the Padavan Law, the proposed Community Residence is to be considered a single "family unit" for local zoning purposes and is, thus, a permitted principal use in the Town's R2-A zoning district. The claims made in the Grauer Letter that the proposed Community Residence is a commercial use and/or is not permitted in the R2-A zoning district, following the application of the Padavan Law, are misguided.

II. New York State Office of Mental Health Licensure

To be clear, Paradigm does not intend to operate a Substance Abuse Treatment Program at the Site. Rather, Paradigm is applying to OMH for licensure as a Community Residence Program, which is defined under 14 NYCRR 594 as follows:

"Community Residence Program (CR) means a program which provides a therapeutic environment for six to eight children and adolescents with serious emotional disturbances whose individual treatment issues preclude family settings or who may need to prepare for independent living. The focus of the program is to develop and implement a plan with the youth and family on how to live successfully and productively in a community, attend school or prepare for employment and develop the skills needed to return to more normative environments. The program emphasizes consumer and family-driven integration in the community, collaboration with other service providers, consumer input and family involvement, and development of community life roles and natural supports."

Thus, the proposed Community Residence, since licensed by OMH, is subject to the Padavan Law. N.Y. Mental Hygiene Law § 41.34. As the Grauer Letter points out, Substance Abuse Treatment Programs are licensed by the New York State Office of Alcoholism and

Substance Abuse Services ("OASAS"). Paradigm is not, and will not, seek licensure from OASAS for the proposed Community Residence.

III. Published Data Regarding Other Community Residential Facilities

The Padavan Law requires that Paradigm notify you of the most recently published data regarding other Community Residential Facilities² in the area surrounding the Site. Though surrounding Community Residential Facilities were discussed at a meeting with the Town held on November 9, 2016, enclosed with this letter is a list of Community Residential Facilities in Westchester County to ensure that you can reasonably "evaluate all such facilities affecting the nature and character of the area wherein such proposed facility is to be located." N.Y. Mental Hygiene Law § 41.34(c)(1)). The only licensed facility in the Town is the Bristal at Armonk, a New York State Department of Health licensed adult care facility for the elderly.

IV. Community Support Requirements

Further, Paradigm's community support requirements would be as follows:

- 1. Paradigm's usage of municipal services, such as police, fire, and paramedics should be no greater than any other residence in the community.
- 2. Paradigm intends to have its residents and visitors to the Site frequent local restaurants and other retail establishments.
- 3. Paradigm will use on-site well water and wastewater treatment facilities.³

It is Paradigm's position that locating this Community Residence within the Town is lawful, appropriate given the nature of the Site, will not create any oversaturation, and will be a benefit to the Town and surrounding area.

¹ The source of the assertion in the Grauer Letter relates to inaccurate information added to Paradigm's website by its webmaster. Paradigm's webmaster incorrectly used certain information associated with its Malibu, CA site as part of its description of the proposed North Castle, NY site as though the programs would be identical. The programs will not be identical and the website has been adjusted accordingly.

² "Community Residential Facility" means any facility operated or subject to licensure by the state which provides

² "Community Residential Facility" means any facility operated or subject to licensure by the state which provides a supervised residence for mentally, emotionally, physically, or socially disabled persons or for persons in need of supervision or juvenile delinquents. This term includes, but is not limited to, community residences for the mentally disabled operated or licensed by the offices of mental health or mental retardation and developmental disabilities or by the divisions of the office of alcoholism and substance abuse, agency operated boarding homes, group homes or private proprietary homes for adults operated or licensed by the department of social services, group homes operated by, contracted for or licensed by the division for youth and half-way houses operated or licensed by the division of substance abuse services. New York Social Services Law § 463(1).

³ Please note that Exhibit 1 to Paradigm's Letter delivered to the Town on November 9, 2016 inadvertently stated that the Community Residence would rely on public water and sewer. Paradigm is confident that the on-site systems are sufficient to accommodate Paradigm's use of the Site as a Community Residence. Paradigm would be pleased to provide documentation confirming the same upon the Town's request.
