## Park and Recreation Facility Repairs and Improvements – Prioritize

• Roofs are #1; Gazebo in Wampus Brook Park is #2; Hergenhan basement waterproofing is #3.

## Hergenhan Basement Waterproofing

- John Kellard brought in 3 contractors to provide quotes ranging from \$17,000 \$29,000. A suggestion was made to have the engineer attend a future rec board meeting to discuss.
- $_{\odot}$   $\,$  Work could possibly start late summer when camp ends and before the Fall classes begin.
- $_{\odot}$  Cost should not come out of rec subdivision money. Maybe we can get State money since our facility is used as an evacuation/emergency site.
- Paid \$14,000 band aid fix just for mold repair, didn't include waterproofing.

#### Playground Improvements – ADA Compliance

- New playground proposal for Winkler approximately \$34,500.
- New playground proposal for Lombardi \$18,000 or \$35 with additional fire engine structure.
- $\circ$  Free installation offered only for the next 7 10 days.
