Brief Description of Proposed Action (include purpose or need): The proposed action involves the 36-acre St. Christopher's/Jennie Clarkson site on the east side of Route 22 in North Castle. The applicant is the contract vendee of ±22 acres of the overall Site, which is located partially in the R-1A and R-2A zoning districts. The applicant proposes a new zoning district (R-MF-R) and be developed to include high end multifamily rental housing units with amenities (on ±12 acres) and permanently preserved open space (±10 acres). Access to the residential site will be provided via two new driveways on Old Orchard Street. The traffic from the development will then proceed to the signalized intersection of Old Orchard Street and Route 22. The 14± acres upon which the Jennie Clarkson Campus is located will remain under its current ownership and operation of the existing facility will continue. The multi-family housing is proposed to include 200 residential units, in two 4-5 story buildings over underground parking (420 spaces total). Forty percent (80 units) of the units will be one-bedroom and sixty percent (120 units) of the units will be two-bedroom. Ten percent of the units (20 units) will be Affirmatively Furthering Fair Housing (AFFH). 8 of the AFFH units will be one bedroom units and 12 will be two bedroom units. The design concentrates construction in the center of the site and maximizes open space, with a conservation easement proposed on the 10 acres to be preserved.


