

NOTICE OF ANNUAL ELECTION
NORTH CASTLE SOUTH FIRE DISTRICT NO. 1

PLEASE TAKE NOTICE, that the Annual Election of the North Castle South Fire District No. 1 will take place on December 12, 2017, between the hours of 6:00 p.m. and 9:00 p.m. at the North Castle South Fire District No. 1 Firehouse located at 621 North Broadway, North White Plains, New York for the following purposes:

To elect one (1) Fire District Commissioner for a five (5) year term commencing January 1, 2018 and ending December 31, 2022; and

To vote upon the following two (2) propositions:

Proposition 1:

“SHALL THE RESOLUTION AUTHORIZING THE SALE AS SURPLUS OF THE 2001 SEAGRAVE QUINT FIRETRUCK, FOR A SUM IN EXCESS OF TWENTY THOUSAND AND 00/100 (\$20,000.00) DOLLARS?”

Be Approved?

Proposition 2:

“RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF THE NORTH CASTLE SOUTH FIRE DISTRICT NO. 1 (“FIRE DISTRICT”) OF THE TOWN OF NORTH CASTLE, COUNTY OF WESTCHESTER, STATE OF NEW YORK, SAID BOARD RESOLUTION ADOPTED ON OCTOBER 16, 2017: AUTHORIZING THE FIRE DISTRICT: (1) TO WITHDRAW UP TO THREE HUNDRED THIRTY THOUSAND AND 00/100 (\$330,000.00) DOLLARS FROM THE CAPITAL RESERVE FUND HERETOFORE ESTABLISHED FOR FIREFIGHTING APPARATUS TO PAY A PORTION OF THE COST OF A NEW QUINT FIRETRUCK; STATING THE MAXIMUM COST OF SAID NEW QUINT FIRETRUCK TO BE EIGHT HUNDRED, SIXTY THOUSAND AND 00/100 (\$860,000.00) DOLLARS AND (2) PURSUANT TO AUTHORITY UNDER SECTION 109-b OF THE GENERAL MUNICIPAL LAW TO ENTER INTO AN INSTALLMENT PURCHASE CONTRACT TO FINANCE, OVER A FIVE (5) YEAR TERM, THE BALANCE OF UP TO FIVE HUNDRED THIRTY THOUSAND AND 00/100 (\$530,000.00) DOLLARS; STATING THAT SAID PURCHASE IS A TYPE II ACTION AND THAT NO FURTHER ACTION WILL BE TAKEN UNDER SEQRA; STATING THAT THE FORM, TERMS AND CONTENT OF SAID INSTALLMENT PURCHASE CONTRACT SHALL SUBSTANTIALLY CONFORM TO THE REQUIREMENTS OF SECTION 109-b OF THE GENERAL MUNICIPAL LAW AND OTHER APPLICABLE STATUTES; STATING THAT THE PRINCIPAL AND INTEREST PAYMENTS SHALL BE DUE IN FIVE (5) EQUAL INSTALLMENTS OF APPROXIMATELY ONE HUNDRED EIGHTEEN THOUSAND SEVEN HUNDRED FIFTY AND 00/100

(\$118,750.00) DOLLARS IN THE YEARS 2019 TO 2023, INCLUSIVE; STATING THE INTEREST RATE TO BE APPROXIMATELY FOUR PER CENT (4.00%) PER ANNUM; AND APPROPRIATING SAID AMOUNTS THEREFOR TO PAY THE PRINCIPAL AND INTEREST WHEN DUE,"

BE APPROVED?

All residents of the North Castle South Fire District No. 1, who are duly registered to vote with the Westchester County Board of Elections on or before November 20, 2017 shall be entitled to vote at this election.

Any person desiring to have his or her name appear on the ballot for the above office must have filed a petition, signed by at least twenty-five (25) qualified electors of the Fire District, with the Secretary of the Fire District, not later than November 22, 2017.
