Using a Powerpoint presentation, Budget and Financial Review Task Force member, Larry Ruisi, gave an overview of the 2012 Preliminary Budget. The following points were presented based on the General, Highway & Library Funds 2012 preliminary figures versus the 2011 adopted budget:

- Expenses for 2012 are increased by 2.08% with a modest increase of 3.1% in revenue. Real property taxes have been increased by 1.8% while the assessed valuation has declined by .4%. This drop is due to the declining value of real estate and no major new development in progress.
- In looking at 2012 expenses, significant increases are budgeted for NYS pension contributions (20%); health insurance (6%) and worker's compensation (20%). Decreases salaries and overtime and reductions in the Town's workforce resulted in a savings of \$182k.
- Budgeted revenues are increased for mortgage taxes (\$100k) and sales taxes (\$75k).
- Based on these changes, the Town Tax Rate would increase by 2.23%.
- A large part of the increase is due to non-controllable expenses, particularly NYS pension and health insurance costs.
- There are several matters under consideration, including budgeting for a Town Administrator and a final review of revenue and expenses.

Mr. Ruisi emphasized that numbers in the 2012 Preliminary Budget will continue to change over the next two weeks while everyone continues to work to get the budget as low as possible.

In response to a question from resident Lydia Rippstein, concerning what can be done to get the State to control mandated expenses, Supervisor Weaver expressed concern that Albany would have to vote to change the way pension contributions are funded.

Councilman Schiliro explained that the NYS pension system is part of the State Constitution and can only be changed at a Constitutional Convention that happens every 20 years, with the next one occurring in 2017. A positive improvement would be for NYS to require pension contributions beyond 10 years of service, but this would have to be addressed as part of a

constitutional effort. Mr. Schiliro added that the Town's labor pool has been reduced by 20% over the past few years and everyone is doing more and working with less.

Supervisor Weaver thanked the Budget and Financial Review Task Force for the enormous amount of time and expertise that the group has invested in the budget review and projections to guide the Town Board. He added that the focus has been to reduce staff while making workers more efficient so that taxes can be kept to the absolute minimum.

He said that there is a complicated formula for calculating the tax levy limit for each Town and North Castle would be required to stay within the cap of \$416,215. Passing the local law is only a precautionary measure should the increase exceed the limit imposed by the State.

In response to an inquiry from Lydia Rippstein, School Street, Mr. Weaver explained that the levy is the amount of revenue which the Town will collect through taxes.

TOWN OF NORTH CASTLE

LOCAL LAW NO. <u>10</u> FOR THE YEAR 2011 (Adopted November 30, 2011)

A Local Law to override the tax levy limit established in General Municipal Law 3-c.

Be It Enacted by the Town Board of the Town of North Castle as follows:

Section 1. Legislative Intent

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of North Castle, County of Westchester pursuant to General Municipal Law Section 3-c, and to allow the Town of North Castle, County of Westchester to adopt a town budget for (a) town purposes; (b) fire protection districts; and (c) any other special or improvement district governed by the town board for the fiscal year 2012 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law Section 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law Section 3-c, which expressly authorizes the town board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the town board.

Section 3. Effective Date

This local law shall be effective immediately upon filing of same with the Secretary of State of the State of New York.
