TOWN OF NORTH CASTLE

Local Law No. <u>4</u> for the Year 2011 (Adopted May 11, 2011)

A Local Law to amend Chapter 7 entitled <u>Architectural Review Board</u> of the Code of the Town of North Castle.

Be It Enacted by the Town Board of the Town of North Castle as follows:

- 1. Section 7.2 <u>Membership and Organization</u>, Paragraphs A and E are hereby amended in part to read as follows:
 - A. The ARB shall be appointed by the Town Board of the Town of North Castle and shall consist of five members, all of whom shall be residents of the Town of North Castle. No member of the ARB shall be an officer or employee of the Town of North Castle. The term of office shall be three years, with expirations of terms to occur according to the rotation established by former Chapter 7. Members shall serve without compensation. Vacancies shall be filled by the Town Board for unexpired terms of any members whose positions on the ARB shall become vacant.

- E. Three members of the ARB shall constitute a quorum for the transaction of business. The ARB shall operate under such rules and regulations as it may adopt insofar as they do not supersede any requirements of this chapter and insofar as they guarantee due process to any applicant. The ARB shall schedule meetings at regular intervals no less frequently than once monthly and in accordance with all provisions of the New York State Open Meetings Law, with the proviso that no meeting shall be required if no cases have been placed on the agenda as of five business days prior to the scheduled meeting start. Please note specific cut-off dates for submission of the minimum required ARB Submission Documents prior to the actual meeting of the ARB. Submission documents received after a specific cutoff date will be scheduled for the next following meeting of the ARB. Please also note that meeting agendas often fill up quickly. If a regularly scheduled meeting agenda is full, subsequent applicants will be accepted for appearance at the next scheduled ARB meeting. Any questions concerning matters involving the ARB should be directed to the Board Secretary.
- 2. <u>Effective Date</u>. This Local Law shall be effective immediately upon filing of same with the Secretary of State of the State of New York.

Assistant Superintendent Sal Misiti gave a presentation which provided details regarding the proposed water rate increase in Water District No. 1. Summary points of the presentation included:

- The source of drinking water for Water District No.1 is from a well on South Kensico Avenue in Valhalla, which currently is capable of delivering 25% of the District drinking water. The remaining portion is purchased from the NYC Kensico Supply.
- The water taking agreement with the NYC Water Board requires payment for all water used and an additional charge for usage in excess of the NYC agreement. This excess per capita charge is calculated by NYC relative to the population of the District. The Water Board agreement only considers residential population of the District; no commercial use is part of the excess calculation.
- The increased purchasing costs along with the District's depleting supply capabilities make it necessary to increase the water rate in Water District No.1. Last year there was a deficit in the water revenue line.
- There are 583 residential accounts and 107 commercial accounts, with the commercial accounts using more of the water. The high commercial usage in North White Plains is forcing the excess per capita costs up, thereby increasing the monthly per capita charge which becomes a burden to the entire District rather than to the properties which are actually using the water.
- Based upon the escalating per capita costs, a fair rate increase, with a separate progressive rate structure for residential and commercial properties, is being proposed based upon levels and type of usage. An analysis shows that the new rate structure would have a slight impact on the residents, and more of an impact on the commercial users.

In response to Supervisor Weaver's query about water usage by Metro North, Mr. Misiti said Metro North is the largest water user in the District and they would be carrying the bulk of the District's water rate increase. He said other businesses, including car washes, also have high water usage.

Mr. Misiti said that steps are being taken to help reduce excessive water costs in the District including planned rehabilitation on the Valhalla well to obtain a better yield; possible upward readjustment of residential population number to allow taking more water without penalty; and performance of leak studies. He said the cost of the rehabilitation work would be \$10,000, which would be much less costly than a new well.

Councilman Schiliro asked if an engineer should be consulted to determine the cost benefit of the well rehabilitation work. Mr. Misiti said that the monthly overage cost currently being paid is \$10,000.

No other correspondence or comments were entered for the record.

Local Law No. <u>5</u> for the Year 2011 (Adopted May 11, 2011)

A Local Law to amend chapter 204 entitled \underline{WATER} of the Code of the Town of North Castle.

Be It Enacted by the Town Board of the Town of North Castle as follows:

1. Section 204-48 <u>Water Rates</u>, Paragraph A is hereby amended to read as follows:

Residential Rate Table Up to 4,250 gals - minimum of \$25.00
