Supervisor Berman called the meeting to order at 5:30 p.m. and the following persons were present:

The meeting was immediately adjourned into Executive Session. The Executive Session was closed at 7:25 p.m.

Supervisor Berman reconvened the regular meeting at 7:35 p.m.

Councilman Weaver moved, seconded by Councilman Geist, approval of the minutes of the January 12, 2009 regular meeting and the February 3, 2009 special meeting.

The roll call vote was as follows:

The minutes of the Public Hearings which commenced at 8:00 p.m. follow at the end of these minutes.

Supervisor Berman made the following announcements:

Motorists who use the Bronx River Parkway near Kensico Dam are advised that a lane closure will be in effect for a section of the parkway due to construction. The closure is scheduled to begin February 17<sup>th</sup> and continue for about 6 weeks. The project is likely to cause traffic delays southbound, particularly during weekday morning rush-hours.

New York State Department of Transportation is continuing to work on I-287 between Exits 6 and 8, including the bridges over the interstate at Lake Street, North Broadway/Route 22, Brockway Place, Westchester Avenue, and Grant Avenue. Work includes drilling and excavation, new retaining walls, sewer and storm water management systems, drainage systems and utility relocation.

Diane Chickering of Suburban Carting reported on the status of the new alternate week recycling program, making the following points:

The program is going well and approximately 80% of North Castle residents recycle.

If residents put out paper on a week when commingled items are to be collected, or vice versa, those recyclables will be left behind with an "Oops" sticker saying that the wrong material has been put out.

Beginning March 16, garbage will be left behind if recyclable materials are mixed in with waste. The instructions for the proper preparation of garbage and recyclables are on the sanitation schedules sent to residents in December.

Councilman Geist said he would prefer that residents first receive a warning or a violation rather than having their garbage left behind. Councilman Schiliro stated that it is not much to ask people to conform to the specifications for recycling, adding that Suburban has communicated to the community several times regarding this issue. Supervisor Berman said she would like to discuss options other than leaving garbage behind; she suggested that we need to find a place where residents can bring recyclables.

Supt. of Public Works Richard Fon suggested that a strong letter be sent to those residents who are not recycling at all. Supervisor Berman asked Mr. Fon and Ms. Chickering to draft a letter to be sent to those residents. The letter should be reviewed by the Town and mailed out by Suburban. The deadline for leaving garbage behind was moved to April 1 when residents who don't recycle at all will have received the letter.

Councilman Kittredge moved, seconded by Councilman Schiliro, the appointment of Tara Ermark to the Landmarks Preservation Committee for a three year term to expire May 17, 2011. Ms. Ermark, who will be replacing her mother Linda Roberts on the committee, reviewed her family's long history in North Castle.

Councilman Weaver moved, seconded by Councilman Geist, the adoption of the Employee Handbook, which was developed to assist union and managerial employees and elected officials in understanding the benefits, policies and procedures of the Town with regard to human resources. Supervisor Berman thanked Comptroller Dawn Donovan, Town Clerk Leber, Asst. Supt. Sal Misiti and Councilman Kittredge for their diligence and persistence in bringing this project to fruition.

Precipitated by concerns expressed in an e-mail from resident Art Elias, Supervisor Berman had invited Jon Powers, Deputy Supervisor of Pound Ridge, to attend the meeting to discuss the deer management plan implemented by his town. Mr. Powers said that, in response to residents' concerns, the Town Board had asked the Conservation Board to look at the forested areas in the region. It was determined that the deer are eating the under story in the wooded areas, which will ultimately destroy the forest, and that culling the herd is the only viable solution. He mentioned that, after fencing off 35 acres of its property, Lasdon Arboretum found two different worlds in terms of regeneration between the fenced and unfenced areas. After reviewing other municipalities' efforts with the problem, the Pound Ridge Conservation Board recommended allowing hunting on three town-owned properties and encouraging private land-owners to allow hunting on their properties. Five public hearings ensued where it was stressed that the goal was to protect the under story and the environment while keeping in mind the safety of the residents. The program that was instituted requires certain safety measures such as permission to bow hunt from the property owner, hunting from tree stands only, possession of a NYSDEC license and a

Pound Ridge hunting tag, and qualification by the Pound Ridge Police Department. In addition, hunters are assigned to a property and must meet quotas. The program is administered by the Pound Ridge police chief and costs approximately \$5,000 annually. Mr. Powers stated that there have been no accidents since the program was implemented.

Mr. Powers went on to say that a study commissioned by Westchester County on white tailed deer and forest regeneration has determined that the deer population in some instances is 63 per square mile; 5 per square mile is considered healthy. The County may consider permitting deer hunting in County parks. Mr. Powers said that Pound Ridge, after three years of success with its program, would like to encourage the County and other municipalities to implement similar deer management programs in order to augment and enhance its own.

Conservation Board Chairman John Fava stated that he believes culling the herd in the only way to reduce the deer population. He added that appropriate areas to allow hunting in North Castle may be Sluder Preserve and Cat Rocks Park. Since the under story protects the watershed, the impact of its destruction has to be looked at carefully.

Councilman Geist suggested that the idea of implementing a deer management plan in North Castle be referred to the Conservation Board for its recommendation. Councilman Weaver concurred. Supervisor Berman commented that North Castle could benefit from the work done by Pound Ridge.

Councilman Geist mentioned that the Association of Towns is looking into a resolution calling for reinstating revenue sharing directly to the towns rather than to NYS. Mr. Geist suggested that a letter be written to Congresswoman Lowey, and Supervisor Berman encouraged him to do so.

Supervisor Berman read aloud excerpts from a letter from Tax Receiver Patricia Colombo regarding tax collections. The Town, County and School tax collections for 2007 and 2008 are as follows:

Ms. Colombo concludes her letter, "Hopefully these results will put many at ease and assist in correcting the rumors regarding the dismal state of tax collection in the Town of North Castle." The members of the Town Board applauded Receiver Colombo and her staff.

# PUBLIC HEARING

#### February 11, 2009

At 8:00 p.m. Supervisor Berman reconvened the Public Hearing which was adjourned from January 28, 2009 for the purpose of considering the adoption of a Local Law to revise Section 213-14.G of the Town Code to permit 8-foot high deer fencing and limit fencing in the front yard to four feet.

A letter from Director of Planning Kaufman, dated February 10, 2009, was marked Exhibit "G" for the record.

Mr. Kaufman reviewed the background leading to the proposed local law which he drafted in response to requests received by the Zoning Board of Appeals for deer fencing at heights of 8 feet and higher. Mr. Kaufman explained that the proposed law would permit up to 8-foot fencing except within the front yard setback. He said that a separate matter, which would prohibit non-deer fences or walls above four feet in the front yard setback, was also being addressed in the proposed law. He said that the Planning Board has recommended that the Town Board take no action on either matter.

Supervisor Berman thanked the Planning Board for its recommendations and said that this was a rare occasion when she was in disagreement with one of its recommendations. Supervisor Berman said she was in support of amending the Code to permit 8-foot mesh deer fencing because six-foot fencing was not effective in keeping deer out. She said she did not support the current practice of requiring the ZBA to review each variance application. She said that she did agree with the Planning Board's recommendation that the Code should not be amended to limit walls and fences to four feet within the front yard setback, and confirmed with Mr. Kaufman that 6-foot fencing is currently permitted anywhere on a property.

John Powers, Deputy Supervisor of Pound Ridge, said that when their zoning board had many requests for deer fencing their town board adopted a law limiting the amount of deer fencing to the lesser of 50% or two acres of the property.

Councilman Weaver said he agreed with Supervisor Berman's recommendations. With regard to deer fencing, Mr. Weaver recommended that fencing be permitted at a fixed distance of 20 or 25 feet from the property line, rather than restricting it within the front yard setback.

Mr. Kaufman recommended that the language of the law be revised to eliminate the need for approval by the ZBA for deer fencing and require approval by the Building Inspector only.

Superintendent of Public Works Richard Fon suggested that the Board may want to consider having deer fencing applications reviewed by the Residential Project Review Committee. Supervisor Berman said that she did not think it was necessary to complicate the process. She asked the Board if they wanted to consider a limit on the amount of deer fencing.

Councilman Geist expressed his view that the process should be kept simple and that it could be revised as necessary at a later time with regard to a limit on the amount of fencing.

Councilman Weaver agreed and said that Mr. Fon could suggest to residents that they not install deer fencing on their entire property. Mr. Fon said that most residents do not.

No other correspondence or comments were entered for the record.

Local Law No. 2 For The Year 2009 (Adopted February 11, 2009)

A local law to revise Section 213-14.G of the Town Code to permit 8-foot high deer fencing.

<u>Section 1.</u> Revise Section 213-14.G(1) of the Town Code as follows:

- G. Walls and fences.
- (1) The yard requirements of this chapter shall not be deemed to prohibit any necessary retaining wall nor to prohibit any fence or wall, subject to applicable permits and reviews by the Building Inspector, and further provided that the finished side of such fencing or wall shall face the exterior of the property as defined by the property line, and provided that such fence or wall does not exceed six feet in height. Mesh deer fencing, exceeding six feet in height shall be permitted to reach a height of eight feet, except that deer fencing over six feet in height shall not be permitted within 25 feet of the front property line.

Section 2. Conflicting Standards.

Where the requirements of this Local Law impose a different restriction or requirement than imposed by other sections of the Code of the Town of North Castle, the Town Law of the State of New York or other applicable rules or regulations, the requirements of this Local Law shall prevail.

Section 3. Severability.

The invalidity of any word, section, clause, paragraph, sentence, part or provision of this local law shall not affect the validity of any other part of this local law that can be given effect without such invalid part or parts.

# Local Law No. 3 For The Year 2009 (Adopted February 11, 2009)

A local law to amend Section 213-22.2.C(1) of the Town Code to be consistent with the approval type required in Section 213-22.2.B of the Town Code.

Section 1. Amend Section 213-22.2.C(1) as follows:

Maximum gross land coverage. The following table establishes the basic and maximum permitted gross land coverage for one- and two-family residences on lots of the sizes indicated, irrespective of zoning district. For any proposed lot development which would exceed the basic permitted gross land coverage as shown in the following table, the Planning Board may, subject to special permit approval and compliance with the standards as set forth in § 213-22.2H below, allow an increase in gross land coverage up to, but not exceeding, the maximum permitted gross land coverage as shown in the table. Notwithstanding said limitations, an additional 10 square feet of gross land coverage shall be permitted for each one foot of front yard setback of the principal dwelling in excess of the minimum front yard setback required. For any new building lot created by subdivision subsequent to the effective date of this section, the "lot area" used for measurement purposes in the following table shall be "net lot area," as defined herein. For any existing lot in a One- or Two-Family Residence District, it shall be "lot area," as defined herein." The basic gross land coverage is allowed subject only to obtaining otherwise applicable permits unless the increase in gross land coverage is proposed in connection with an application requiring Planning Board review, in which case Planning Board site plan approval shall be required.

Section 2. Conflicting Standards.

Where the requirements of this Local Law impose a different restriction or requirement than imposed by other sections of the Code of the Town of North Castle, the Town Law of the State of New York or other applicable rules or regulations, the requirements of this Local Law shall prevail.

Section 3. Severability.

The invalidity of any word, section, clause, paragraph, sentence, part or provision of this local law shall not affect the validity of any other part of this local law that can be given effect without such invalid part or parts.

Section 4. Effective Date.

This Local Law shall take effect immediately upon its adoption and filing with the Secretary of State.
