The minutes of the Public Hearing that commenced at 8:15 p.m. follow at the end of these minutes.

Pursuant to a request from North Castle Cares Coalition, Councilman D'Angelo moved, seconded by Councilman DiGiacinto, a Resolution proclaiming April 20, 2016 as "Healthy Teen Brain Day" to applaud and support our youth who are making healthy decisions.

A lengthy discussion ensued with regard to the resolution being considered by the Town Board to extend Water District No. 2 to include the Brynwood Golf & Country Club. Some members of Residents of Windmill, Inc. (ROWI) spoke regarding their concerns with water quality and hardness. Information regarding these concerns was provided by the Town's consulting Hydrogeologist, Bill Canavan of HydroEnvironmental Solutions; Leggette, Brashears & Graham Hydrogeologist, Tom Cusack; and Director of Water and Sewer Operations, Sal Misiti.

Supervisor Schiliro said this is a very important application which has been properly vetted, through public hearings, meetings, mailings and information provided, with respect to all concerns. The Supervisor said that the applicant will produce the minimum gallons of water needed and will pay for the infrastructure. With regard to a request from some Windmill residents to require a buy-in fee from the applicant, Mr. Schiliro said that with the opportunity to significantly reduce the assessment for residents in the entire district, it is necessary to take the responsible fiduciary action rather than require a buy-in fee as a condition of approval and risk losing all of the tax savings for the residents.

With regard to the application of Brynwood Partners LLC for the extension of Water District No.2, Councilman D'Angelo moved, seconded by Councilman Reiter, the adoption of the Resolution, which follows at the end of these minutes, to extend the boundaries of Water District No. 2 to include all property listed as Exhibit "A" of the Resolution.

WHEREAS, on February 24, 2016, the public hearing was reconvened and considerable discussion upon the matter having been had and all persons desiring to be heard having been duly heard, and thereupon the hearing was duly closed.

WHEREAS, an order was duly adopted by said Town Board on June 24, 2015, reciting a description of the boundaries of said proposed Park District, the improvements proposed therefor, the maximum amount proposed to be expended for said improvements, the proposed method of financing to be employed, the fact that said map, plan and report were on file in the Town Clerk's office for public inspection, and specifying the 22nd day of July, 2015, at 8:00 o'clock P.M., Prevailing time, at the Town Hall, 15 Bedford Road, in Armonk, New York, in said Town, as the time when and the place where said Town Board would meet for the purpose of holding a public hearing to hear all persons interested in the subject thereof concerning the same; and

WHEREAS, such order was duly published and posted in the manner and within the time prescribed by Section 209-d of the Town Law and mailed to each affected property owner, and proof of such publication and posting has been duly presented to said Town Board; and

WHEREAS, said public hearing was duly held at the time and place set forth in said order, as aforesaid, at which time all persons desiring to be heard were duly heard at which time said public hearing was adjourned; and

WHEREAS, said public hearing was re-convened on August 5, 2015, at which time all persons desiring to be heard were duly heard and the public hearing was then closed; and

WHEREAS, following said public hearing, and based upon the evidence given thereat, said Town Board duly adopted a resolution determining in the affirmative all of the questions set forth in subdivision 1 of Section 209-e of the Town Law and a second "approval resolution" approving the establishment of the Long Pond Park District was also adopted at said time; and

WHEREAS, in response to an application duly made pursuant to subdivision 3 of Section 209-f of the Town Law, the State Comptroller has duly made an order, in duplicate, dated March 5, 2016, granting permission for the establishment of the Long Pond Park District, one copy of which has been filed in the office of the Town Clerk and which has been submitted to said Town Board;

NOW, THEREFORE, IT IS HEREBY ORDERED,

by the Town Board of the Town of North Castle, Westchester County, New York, as follows:

Section 1. Long Pond Park District in the Town of North Castle, Westchester County, New York, in accordance with the aforesaid Order of the State Comptroller, is hereby established to include the tax lots as shown in the Tax Assessment Maps of the said Town set forth in **Exhibit** A hereto:

<u>Section 2</u>. The project costs and financing are as set forth in **Exhibit B.**

Section 3. The Town Clerk is hereby authorized and directed to cause a certified copy of this order to be duly recorded in the office of the Clerk of Westchester County, New York, within ten (10) days after the adoption of this order by this Town Board and to file a certified copy thereof within that time in the office of the State Department of Audit and Control, in Albany, New York, both pursuant to subdivision 1 of Section 209-g of the Town Law.

<u>Section 4</u>. This order shall take effect immediately.

I. <u>INTRODUCTION</u>

The Town of North Castle intends to create a special district for the purpose of funding improvements and long term programs for Long Pond Dam. The Long Pond Dam Maintenance District would encompass those properties which have a direct benefit use of Long Pond, inclusive of residential homes fronting on or across the street from Long Pond. Dam Maintenance District responsibility would include the financing of costs associated with required engineering studies, improvements and long term maintenance and reporting required to comply with the NYSDEC Dam Safety Program.

Long Pond is located within the residential Windmill community, in the Town of North Castle, Westchester County, New York. The pond is slightly less than nine (9) acres, with a length of 2,000 feet and a width between 150 - 400 feet. Approximately 28 million gallons of water are retained behind the ± 40 foot high and 25 foot wide earthen fill embankment which was constructed in the 1930's. The dam has been classified as a Class "B" Intermediate Hazard structure which could cause damage to homes and roadway if the dam fails.

There are eighteen (18) properties surrounding the pond which have direct benefits of the pond. Long Pond is owned by the Town of North Castle, however, the dam is located on privately-owned parcels. It is not realistic to expect the two (2) property owners, for which the dam is located, to incur the full costs required to improve and maintain the dam. The district formation has been proposed to fairly distribute the costs of the dam improvements and long term maintenance requirements equally between all eighteen (18) property owners and the Town of North Castle. New York State Law does not permit the Township to participate within the proposed district. Since Long Pond is a Town amenity accessible to all residents, the Town intends to obligate itself to the District through contract.

New York State Department of Environmental Conservation (NYSDEC) Dam Safety Program representatives have inspected the dam and have determined that repairs are necessary to bring it into compliance with present NYSDEC Dam Safety Regulations. Furthermore, safety inspections, engineering assessment and other evaluations are required to confirm the dam's safety. Future management of the dam must proceed under an Inspection and Maintenance Plan, an Emergency Action Plan must be developed, records need to be kept and annual certifications must be provided to the Department.

V. <u>AMENDED - DISTRICT BOUNDARY</u>

The district boundary is proposed to include those properties surrounding Lond Pond which have a direct beneficial use of the lake. There are eighteen (18) parcels which directly front onto the pond or across the street from the pond. The boundary is depicted on the Long Pond Dam District Map, prepared by Kellard Sessions Consulting, P.C. and dated (last revised) June 11, 2015 (Appendix A). A list of the tax designation, address, present owner and assessed value of each parcel follows:

VII. AMENDED - PROJECTED COSTS AND FINANCING

Project costs consist of capital construction costs, engineering costs and annual operation and maintenance costs. Capital construction costs include improvements required to bring the dam into compliance with present Dam Safety Regulations, which would include Phase I tree removal improvements and projected Phase II improvements.

Engineering costs represent initial costs to assess the dam, preparation of plans and specifications and the preparation of an Inspection and Maintenance Plan and Emergency Action Plan. Operation and maintenance costs include ongoing inspections and assessments, updating programs and plans and annual maintenance of the dam and appurtenances. Estimated costs are outlined as follows:
