The meeting was called to order at 6:00 p.m. at 15 Bedford Road on the duly adopted motion of Councilman D'Angelo and immediately adjourned into executive session. Recognition proclamations for years of service were presented to Reverend John Quinn of St. Patrick's Church in Armonk and Rabbi Douglas Krantz, Congregation B'Nai Yisrael.

The Friends of the North Castle Public Library were recognized for receipt of ARTS Westchester 2013 Community Award with regard to their success in establishing the Armonk Outdoor Art Show as a cultural Hub in Westchester County. The award to Friends of the North Castle Public Library recognized the extraordinary vision and leadership in using the Arts to improve community life, to increase access to cultural experiences and to enrich the county's cultural experiences. Debbie Heidecorn accepted the award on behalf of the FNCPL.

Gordon Deering, VHB Engineering, presented the report on Town's pavement management program, which was received on the duly adopted motion of Supervisor Arden.

Mr. Deering's presentation emphasized the following:

- The VHB model includes inventory and measurement of pavement conditions used to develop Pavement Condition Indexes or "PCI's". The ratings are used to develop a plan of road repairs. Data can be filtered and reevaluated over time to develop a strategy for treatment.
- Roads rated under a score of 60 are deemed necessary to rehabilitate. The average rating Town wide is a score of 65, supporting the conclusion that Town roads are in relatively poor condition.
- An expenditure of \$26M would be necessary to rehab all roads needing attention. With an annual expenditure of \$1.3M, road conditions would be maintained as they are today.
- The Town will have the data developed by VHB for use by staff to evaluate and develop work plans.
- Ultimately, it is up to the Town Board to determine what type of road conditions and what level of funding they are comfortable with.

Town Administrator Goldberg introduced Police Chief Fisher and other presenters to provide a review on Police Department initiatives:

Chief William Fisher gave an overall progress report for the Police Department. Lieutenant Peter Simonsen reported on the Department's new records management system. Sargent James Cuffe spoke about the need for a SRO (School Resource/DARE Officer) and a grant application that is being submitted for funding for this position.

Lieutenant Geoffrey Harisch reported on community relations, programs and events.

Supervisor Arden said that revised local law must be referred to the Planning Board and the hearing will be adjourned tonight and reconvened following receipt of their report.

Director of Planning Adam Kaufman said this draft law that was finalized last week must be referred to the Planning Board for their report back to the Town Board. Mr. Kaufman said that a previous draft proposed essentially a commercial zoning district starting with a GB-B zoning district and taking out the more intensive uses, but at its core was commercial business similar to other commercial zones in Town. Based upon subsequent meetings, the Town Board is now considering a residentially based zoning district similar to any other residential district, but designated with a B, rather than an A, because the Town Board is considering the addition of some commercial uses to the core residential zone. The major principal permitted use would continue to be single family residential, but as accessory uses the Town Board is considering up to 1,000 square feet of office use, 1,000 square feet of retail use, and some additional storage of commercial vehicles.

In response to a query from Supervisor Arden regarding the grandfathering of present uses, Mr. Kaufman said the grandfathering uses are not included in the law as they are discussed in a different section of the zoning chapter and thereby would be applicable in this zoning district.

Supervisor Arden said the hearing will be adjourned and when it is reconvened public comments will be received by the Board.

Michael Fareri suggested that aerial photography of the area be provided at the Planning Board and at the Town Board meeting when the public hearing is reconvened. Mr. Fareri said that property owners who would like to change their use should not be required to receive approval from the Zoning Board of Appeals.

No other correspondence or comments were entered for the record.

PUBLIC HEARING

June 11, 2013

At 9:05 p.m. Supervisor Arden reconvened the Public Hearing which was adjourned from May 21, 2013 to consider the petition, map, plan and report in the matter of the extension of Sewer District No. 2 to include Cox Avenue Extension (95, 97, 99 and 101 Cox Avenue).

The following correspondence was received since May 21, 2013:

Letter from GHD Engineering Consulting, P.C. dated June 4, 2013 regarding over allocations of several Sewer District No. 2 properties in relation to the subject properties on Cox Avenue in the petition.

Proposed Resolution to extend Sewer District No. 2, including the Negative Declaration.

Kory Salomone, Veneziano & Associates, appeared before the Board on behalf Frank Madonna. Summarizing from the May 21, 2013 hearing, Mr. Salomone said the petition is for the extension of Sewer Distirict No. 2 to 95, 97, 99 and 101 Cox Avenue and that Mr. Madonna proposes to subdivide 95 Cox Avenue into two lots which would extend the district to five lots. Mr. Salomone said each of the five lots would require 300 gallons per day (gpd) of sewer capacity and they have identified five properties already in the district which in their opinion have been over allocated at 600 gpd. Referencing the 2009 Stearns & Wheeler report, Mr. Salomone said that the sewer allocations in the report are based strictly on zoning. He said the five properties in the district would not be able to be subdivided. He said he was not sure who GHD had spoken with and invited the Board to speak with the Town Engineer and Town Planner and get to their thoughts on further subdivision and whether the 600 gpd is really required.

Supervisor Arden said the Board requested GHD to provide a quick analysis of the petition; and GHD provided a conservative wait and see response, not an endorsement. Mr. Arden said GHD is not familiar with the subject parcels and there is a gray area on whether or not there is capacity. He asked Sal Misiti, Director of Water and Sewer Operations to comment. Mr. Misiti said the Board asked GHD to do a study of the overall additional capacity at the sewer treatment plant, what may be needed and next steps. He said it makes sense for all of Cox Avenue to be connected to the sewer district and there may be some wiggle room for the subject properties, but he was not sure. Mr. Misiti said he would like to see the full GHD study which they said would be completed in about four weeks. He said it is for the Board to decide if they want to make the decision regarding the extension now or wait for the full study.

Michael Fareri said he thought the study should be completed and then a decision should be made.

Al Della Vecchia, 99 Cox Avenue, asked the Board to consider the environmental and health issues and to extend the district to the remaining Cox Avenue properties.

Tony Veneziano, Veneziano & Associates, said the results of the study would not necessarily impact the Cox Avenue extension, but that it could create other issues regarding sewer capacity which could cause further delays.

Jose Berra, Rose Hill Dive, said he and his neighbors, the Hinrichs, had spearheaded the Rose Hill Drive and Cox Avenue sewer extension and that it was prudent to wait for the results of the study.

In response to a query from Councilman D'Angelo, regarding whether he thought the Board should wait for the study, Mr. Misiti said he thought there was wiggle room, but that it why the Town hired the professionals to do the study and obtain information.

Supervisor Arden said the total capacity which would be added to the system is .003, which is 3/10 of one percent of the total capacity and that amount is relatively insignificant based on the wiggle room expected to be there. Mr. Arden said the conditions are now a public health issue and the public good outweighs the uncertainty. He said the sewer extension will increase the residents' property values and the best course of action is to provide sewers for the residents and thereby enhance the Town.

In response to an issue raised by from Michael Fareri regarding campaign donations received by Councilman DiDonato Roth from members of the Madonna family, Town Attorney Baroni said his recommendation was that Ms. DiDonato Roth should abstain from voting on the extension.

Councilman Schiliro agreed that sewers should be added whenever possible, but thought it may be beneficial to wait for the study. In response to his query to Mr. Misiti confirming that the study would not address every property at its maximum use, Mr. Misiti said the reserve issue would be addressed in the study and there may be many other issues to consider.

Mr. Veneziano asked if the four Board members could be polled and the hearing be adjourned if the Board is not going to vote on it.

Councilmen Cronin, D'Angelo and Schiliro said they were comfortable with moving forward with the extension.

After all persons were heard who desired to be heard, Supervisor Arden moved, seconded by Councilman Cronin that the Public Hearing be closed at 9:40 p.m.
