Town Board Minutes Regular Meeting Town of North Castle 15 Bedford Road Armonk, New York on February 24, 2016

The Town Board meeting was called to order at 5:15 p.m. at Town Hall and immediately adjourned into an Executive Session on the duly adopted motion of Councilman D'Angelo. All Town Board members, the Town Attorney, and the Town Administrator were present for the Executive Session. The Executive Session adjourned at 7:30 p.m. The Town Clerk joined the regular meeting which reconvened at 7:40 p.m. and the following persons were present:

The minutes of the Public Hearings that commenced at 8:15 p.m. follow at the end of these minutes.

Councilman Reiter moved, seconded by Councilman D'Angelo, approval of the minutes from the February 10, 2016 meeting.

Vote: Unanimous

Councilman D'Angelo moved, seconded by Councilman DiGiacinto, receipt of Fareri application for 37 and 41 Maple Avenue regarding Zoning Text Amendments and Special Use Permit and further moved the following:

For Town Attorney Baroni and Director of Planning Kaufman to draft legislation to amend Section 355-22 of the Town of North Castle Town Code to add additional clarifying language regarding multifamily dwellings located on the first floor within the CB-A Zoning District, as well as multifamily dwellings located on the second floor within the CB-A Zoning District regarding six Affordable Housing (AFFH) units, consisting of three two-bedroom and three one-bedroom units, two ground level and four second story level, and maintenance of ground level retail frontage and extension of sidewalks for 37 and 41 Maple Avenue;

To consider authorization to move the Affordable Housing units from the property located at 156 and 170 Bedford Road, known as the Lumberyard, to Maple Avenue; and to require a deed restriction limiting the total number of units to be built at the Lumberyard property to 30 Market Rate residential units, a reduction from the 30 Market Rate and 6 Affordable Housing units previously approved.

It is required and agreed to by Mr. Fareri that he will build both of the aforementioned residential developments, with the requirement that the Affordable Housing property be completed prior to the Market Rate development; the Affordable Housing units must all have Certificates of Occupancy before any Certificates of Occupancy can be issued for the Market Rate units at the Lumberyard.

Zoning Amendments will be presented to the Town Board at the March 9, 2016 Town Board meeting. Pending approval, the Town Board will declare its Intent to Act as Lead Agency, refer the amendments to the Planning Board and the County Planning Board and schedule a Public Hearing. Vote: Unanimous

Councilman D'Angelo moved, seconded by Councilman DiGiacinto, receipt of Planning Board recommendation to reduce the construction performance bond for the Byram Ridge Road Subdivision based on the work completed, and further moved authorization to reduce the cash bond from \$138,880 to \$82,293.30 and issue a payment to Byram Ridge Estates LLC in the reduction amount of \$56,586.70.

- Authorization for the Supervisor to sign all contract agreements, and
- Authorization of a budget transfer of the necessary funds (\$43,101) from Water District No. 4 fund balance into the district operating budget.

Regarding the rehabilitation of existing overburden water supply well, Well No. 4, Town of North Castle Water District No. 2, Councilman DiGiacinto moved, seconded by Councilman D'Angelo, the following:

- Award of bid to the low bidder, Stephen B. Church Company, for \$27,850;
- Authorization for the Supervisor to sign all contract agreements, and
- Authorization of a budget transfer of the necessary funds (\$27,850) from Water District No. 2 fund balance into the district operating budget.

Councilman Reiter moved, seconded by Councilman D'Angelo, receipt of a letter from Westchester County Department of Parks, Recreation and Conservation stating that the annual license fee for the Fisher Lane commuter parking lot will be \$31,378 for the period of April 1, 2016 to March 31, 2017, an increase of 3%, and further authorized the Supervisor to sign the agreement. Vote: Unanimous

Councilman D'Angelo moved, seconded by Councilman Berra, receipt of Town Wastewater Treatment Plant Capacity Increase Study for Sewer District No. 2; a presentation on this study is scheduled for the March 9, 2016 Town Board meeting.

Vote: Unanimous

Receipt of a cash bond for Cox Avenue improvements was tabled at the request of the developer Frank Madonna.

Councilman D'Angelo moved, seconded by Councilman Reiter, approval of the 2015 Budget Transfers and Capital Project funding items that are attached to the end of these minutes, as requested by Administrator Goldberg.

Councilman D'Angelo moved, seconded by Councilman Reiter, authorization for the Supervisor to sign the Renewal Agreement with Westchester Food Services for the food concession at the Anita Louise Ehrman Recreation Center/Town pool to Westchester Food Service, for the period May 15, 2016 through September 15, 2016, for \$2,200 plus a \$300 utility charge.
