TOWN OF NORTH CASTLE

Local Law No. 3 of the year 2015 Adopted April 8, 2015

A local law to amend Section 213-21 Part 2 of the Town of North Castle Town Code to permit personal training facilities as a permitted principal use within the IND-AA Zoning District

Section 1. Amend Section 213-21 Part 2 of the Town of North Castle Town Code to add the following permitted principal use to the IND-AA Zoning District:

Personal Training Facilities

Section 2. Conflicting Standards.

Where the requirements of this Local Law impose a different restriction or requirement than imposed by other sections of the Code of the Town of North Castle, the Town Law of the State of New York or other applicable rules or regulations, the requirements of this Local Law shall prevail.

Section 3. Severability.

The invalidity of any word, section, clause, paragraph, sentence, part or provision of this local law shall not affect the validity of any other part of this local law that can be given effect without such invalid part or parts.

Section 4. Effective Date.

This Local Law shall take effect immediately upon its adoption and filing with the Secretary of State.
