

NOTICE OF ANNUAL ELECTION  
NORTH CASTLE FIRE DISTRICT NO. 2

PLEASE TAKE NOTICE, that the Annual Election of the North Castle Fire District No. 2 will take place on December 10, 2019, between the hours of 6:00 p.m. and 9:00 p.m. at the North Castle Fire District No. 2 firehouse located at 400 Bedford Road, Armonk, New York for the following purposes:

To elect one (1) Fire District Commissioner for a five (5) year term commencing January 1, 2020 and ending December 31, 2024; and

To vote upon the following proposition:

SHALL the bond resolution of North Castle Fire District No. 2, in the Town of North Castle, Westchester County, New York, entitled: "BOND RESOLUTION OF NORTH CASTLE FIRE DISTRICT NO. 2 ("FIRE DISTRICT")", IN THE TOWN OF NORTH CASTLE, WESTCHESTER COUNTY, NEW YORK, ADOPTED OCTOBER 14, 2019, AUTHORIZING THE PURCHASE OF A PUMPER FIRE TRUCK, INCLUDING APPARATUS AND EQUIPMENT USED IN CONNECTION THEREWITH, FOR USE BY THE FIRE DISTRICT; STATING THE ESTIMATED MAXIMUM COST THEREOF IS NOT TO EXCEED \$850,000, INCLUDING PRELIMINARY COSTS AND COSTS INCIDENTAL THERETO AND TO THE FINANCING THEREOF; APPROPRIATING SAID AMOUNT THEREFOR; AUTHORIZING THE ISSUANCE OF BONDS IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$850,000 TO FINANCE SAID APPROPRIATION; DETERMINING THAT, PURSUANT TO THE STATE ENVIRONMENTAL QUALITY REVIEW ACT ("SEQRA"), THE ACQUISITION OF SAID TRUCK IS A TYPE II ACTION AND DOES NOT REQUIRE ANY FURTHER REVIEW; STATING THAT THE PERIOD OF PROBABLE USEFULNESS OF SAID PROJECT IS TWENTY (20) YEARS AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE PRINCIPAL OF SAID BONDS AND THE INTEREST THEREON AS THE SAME BECOME DUE AND PAYABLE," BE APPROVED?

All residents of the North Castle Fire District No. 2, who are duly registered to vote with the Westchester County Board of Elections on or before November 20, 2019 shall be entitled to vote at this election.

Candidates, wishing to have their names printed on the ballot for the above office, must submit to the Secretary of the North Castle Fire District No. 2 at 400 Bedford Road, Armonk, New York, a written request accompanied by a petition signed by at least twenty-five (25) qualified voters of said Fire District not later than November 20, 2019. Fire District Officers must, at the time of the election and throughout the term of office, be a resident of the Fire District.
