Zachary Goldstein appeared before the Board and explained that he is the property owner and proprietor of a new restaurant with accessory brewing use opening at 873 North Broadway,

North White Plains for which he has submitted a new liquor license application to the New York State Liquor Authority. Mr. Goldstein expressed concern that the existence of a Church within 200 feet of his restaurant may infringe on his ability to obtain a liquor license. The Liquor Authority prohibits the issuance of new liquor licenses at locations that are within 200 feet of a church or house of worship. Town Attorney Roland Baroni indicated that the Town Board may be able to waive the 200 foot requirement and directed Mr. Goldstein to speak to his attorney to confirm that the Town Board does in fact have this authority and then write a letter requesting a waiver to the Town Board.

Supervisor Schiliro indicated his intent to work with Mr. Goldstein to ensure that he will be able to open his business as planned and Mr. Baroni agreed to confer with Mr. Goldstein's attorney if necessary.

After all persons were heard who desired to be heard, Councilman Berra moved, seconded by Councilman Hussain, that the Public Hearing be adjourned at 8:16 p.m.
