Town Board Minutes Town of North Castle 15 Bedford Road Armonk, New York on July 11, 2012

The meeting was called to order at 5:30 p.m. on the duly adopted motion of Councilman D'Angelo and immediately adjourned into executive session. All Town Board members and the Town Attorney were present for the executive session which closed at 7:30 p.m. The Town Clerk joined the regular meeting which reconvened at 7:40 p.m.

Supervisor Arden stated that he asked Town Clerk Curran to review and revise the June 27th Town Board minutes, as he believed that the remarks in reference to the Compensation and Benefits Manual reflected more attention to citizen remarks that opposed the policy changes and other remarks in support of benefit reductions were abbreviated. Anne Curran explained that she reviewed the video tape and did not feel the minutes should be changed since much of the speaker's remarks was not related to material included in the policy manual, and therefore not under consideration by the Town Board. The Supervisor requested that an addendum he would provide be made part of the record, and the Town Clerk agreed to this.

Councilman Schiliro moved, seconded by Councilman D'Angelo, approval of the minutes of the June 27, 2012 meeting.

Note: At the July 25, 2012 Town Board meeting, Councilman Roth moved, seconded by Councilman Cronin, approval of the minutes of the June 27, 2012 meeting to include the Supervisor's addendum.

With regard to the Special Use Permit application of St. Nersess Armenian Seminary, all Town Board members praised the applicant and their professionals for adjustments to their plans in order to compromise and work with requests of the Town and most residents. Councilman DiDonato Roth emphasized her concern was related to parking and safety and requested that the Seminary work to contain parking on site for special events.

Councilman Cronin commended the applicant's efforts and expressed his support for the work of St. Nersess, but stated his objection to the proposed location of the seminary. Based on research from NYS Department of Transportation, he stated that this area of Route 22 is the fourth most heavily trafficked in Town, and that he believed that the traffic study conducted by the Town's professional did not take into account the intent of the Seminary to expand its operations. Stating that the project reflects a major intensification of use of the property, he said that the occupancy level is too high and the density of the project is too great.

Commenting that the application was submitted over nine months ago, Supervisor Arden applauded both the applicant and professionals for their patience, and the analysis of Councilman Cronin, that as a result, made the project better for the entire community. He said that he believed that this is a good project and he would support it and welcome St. Nersess to North Castle. Town Board Minutes July 11, 2012

Supervisor Arden moved, seconded by Councilman D'Angelo, approval of a Special Use Permit for St. Nersess Armenian Seminary, Inc. for the renovation and adaptive reuse of existing buildings and construction of a new theological center located at 486 Bedford Road.

With regard to the scheduling of a public hearing to consider the CVS Special Use Permit application, Jeffrey Baker, Young/Summer LLC, on behalf of Concerned Citizens of Armonk, submitted a letter to the Town Board dated July 11, 2012, and summarized his objections, including that the public hearing not be scheduled until the SEQR process was completed and the request that Councilman DiDonato Roth recuse herself from voting or taking part in discussion concerning the property. In response, Town Attorney Baroni stated that the SEQR Act does not preclude the Board from opening the public hearing and to keeping it open pending the receipt of environmental determination from the Planning Board.

Councilman D'Angelo expressed his concern that many people could be out of town and miss a Public Hearing scheduled for July, and the possibility of further inconvenience by reconvening the Hearing in August. Councilman Schiliro questioned the timing of a July 25th Public Hearing, particularly if the final environmental determination is not available.

Councilman DiDonato Roth moved, seconded by Councilman Cronin, receipt of memos from Director of Planning Kaufman and Kellard Sessions Consulting, P.C. regarding CVS Special Use Permit application, and further moved the scheduling of a public hearing for July 25, 2012.
