The Town Clerk noted that certificates denoting mailing of Notices of the hearings to adjacent property owners were in order.

The Town Clerk noted that at the June 23, 2021 Town Board meeting, the Town Board accepted the Draft Environmental Impact Statement (DEIS), and the Draft Generic Environmental Impact Statement (DGEIS), dated June 23, 2021, as complete; and established a comment period until September 30, 2021.

The Town Clerk noted that the Notice of Completion of the accepted DEIS and DGEIS, dated June 24, 2021, was sent to all Involved and Interested Agencies.

The Town Clerk noted there was a proposed Local Law for consideration.

Correspondence and documents previously received by the Town Board from the applicant, Town consultants, and government agencies are available on the Airport Campus landing page of the Town website.

Councilman DiGiacinto provided facts regarding the proposed Airport Campus development at 113 King Street which is the former MBIA property of approximately 38 acres and zoned DOB-20A.

Town Attorney Roland Baroni provided an overview of the process for the public hearings.

Anthony Veneziano, Veneziano & Associates, representing the applicant Airport Campus I II, III, and IV appeared before the Board. Mr. Veneziano noted that Steve Weis, who is a partner in the project, and Geoff Ringler, the project manager, were not able to attend the hearing.

Aaron Werner, AKRF, Inc. gave a PowerPoint presentation of the proposed project and site.

Jane Black, Co-Chair of the Conservation Board, requested a referral on the project to the Conservation Board; and noted that the site is on the Open Space Index. Director of Planning Adam Kaufman noted that the Conservation Board was sent the Notice of Completion. Town Attorney advised that a referral to the Conservation Board could be made.

There were no additional comments from the public.

Town Board members and Mr. Baroni provided questions and comments to Mr. Werner and Mr. Veneziano.

Town Attorney Baroni noted that the answers to the questions presented at the public hearing would be provided in the FEIS.

Mr. Baroni advised that the comment period date of September 30, 2021 could be flexible depending upon when the Town Board closes the public hearing.

After all persons were heard who desired to be heard, Councilman Hussain moved, seconded by Councilman Reiter, that the two Public Hearings be adjourned at 9:45 p.m., and be reconvened at the September 9, 2021 Town Board meeting.
