In regard to the matter of Paradigm Treatment Centers LLC to establish a community residential facility for the mentally disabled at 14-16 Cole Drive, Town Attorney Baroni stated that the Town received the determination of the Commissioner of the New York State Office of Mental Health. Mr. Baroni said that under the Mental Hygiene Law, Section 41.34 the Town has 30 days to appeal that determination, which period of time expires May 12, 2017. Attorney Baroni is seeking authorization for the Town Attorneys to initiate an Article 78 Proceeding challenging the portion of the determination that deferred the decision on the determination of lack of need.

Supervisor Schiliro said that this matter had to be addressed at a Special Meeting in order to file the Article 78 proceeding within the time period allowed by law.

Councilman D'Angelo moved, seconded by Councilman DiGiacinto, authorization for the Town Attorneys to commence an Article 78 Proceeding against the Commissioner of Mental Health of the State of New York, the Office of Mental Health of the State of New York, and Paradigm Treatment Centers LLC in the matter of 14-16 Cole Drive.
