The meeting was called to order at 6:00 p.m. at 15 Bedford Road on the duly adopted motion of Supervisor Arden and immediately adjourned into executive session. Supervisor Arden, Council members Cronin and DiDonato Roth and the Town Attorney were present for the executive session which closed at 7:20 p.m. The Town Clerk joined the regular meeting which reconvened at 7:35 p.m. and the following persons were present:

The November 6, 2013 Town Board meeting minutes were duly adopted on the motion of Councilman DiDonato Roth.

The minutes of the Public Hearings that commenced at 8:20 p.m. follow at the end of these minutes.

Councilman DiDonato Roth called on representatives of the Engel Burman Group, Steven Kreiger and Nancy Campagna, who presented a \$25,000 check to the Town Board as sponsorship donation for the restoration of the Eagle. They spoke about the Bristal Senior Living Center, scheduled for a February, 2014 opening. They said they look forward to establishing good community relationships and to providing a welcoming environment for senior residents. The Town Board expressed gratitude for the generous donation to the Eagle restoration.

Nanette Yarocek and Connie Quarry, representatives of the Eagle Restoration Committee, spoke of the Eagle's history and the plans for replacement of the wood structure with a metal structure.

Councilman DiDonato Roth called on Director of Planning Kaufman to describe and display samples of Welcome to North Castle hamlet signs and new street signs. The locations presented by Mr. Kaufman were samples of where signs could be located, as he said final decisions would be up to the Town Board.

Members of the Beautification Committee were recognized with proclamations for their efforts in enhancing the natural beauty and streetscapes in the three hamlets in North Castle.

Director Sal Misiti, Water and Sewer Operations, reported on emergency generator upgrade work which was purchased and installed in-house and thereby saved approximately \$15,000 by using the Town's own work force. The Supervisor thanked Mr. Misiti for his efforts.

Councilman Cronin moved, seconded by Councilman DiDonato Roth, adoption of the following resolution for the Town to acquire NYS owned land east of Maple Avenue at the intersection of Route 22 (Wampus Brook Park-South).

WHEREAS, the Town of North Castle submitted a request (Request # 1309, Surplus Case File # 08-III-8202) to the NYS DOT to acquire 20,600± s.f. of State-owned land on the east side of Maple Avenue at the Intersection of NYS Route 22, which is a portion of Map 41, Parcel 53 acquired by the State on December 28, 1966, for the construction of an expanded park within Wampus Brook Park and is officially requesting that the NYS DOT convey this parcel to the Town of North Castle for \$1 payment waived; and

WHEREAS, the Town of North Castle acknowledges that, as a condition of sale, the New York State Department of Transportation will retain a permanent easement over the property for culvert maintenance/repair/replacement; and

WHEREAS, if the request to obtain the land is approved, the Town of North Castle agrees to accept ownership and maintenance responsibility for the subject parcel (excluding culvert maintenance/repair/replacement); and

WHEREAS, the Town Supervisor is authorized to execute any agreements/documents on the Town of North Castle's behalf that are necessary to complete the conveyance and file the deed in the office of the Westchester County Clerk; and

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby fully supports, and agrees to all of the statements contained above; and

BE IT FURTHER RESOLVED, the Town Board hereby requests that the New York State Department of Transportation transfer the "Wampus Brook Park – South" land from the NYSDOT for \$1 Payment Waived.

Conservation Board Chairman Fava stated his objections to the tree removal at Wampus Brook Park South, and concerns over the lack of procedure in developing the park's landscape plan without input from the Conservation Board, Planning Dept., Parks Board, Town Engineer and all the professionals that are available to determine the best decisions for a project such as this.

Kerri Kazak, Chair of Open Space Committee, expressed her support of John Fava's comments. She asked what is the rush in getting this work done, and why wasn't the normal process involving other associated groups followed. Ms. Kazak said the Parks and Recreation Board is an advisory party and does not have the power to approve plans such as this without a process to include input from other advisory parties and ultimately Town Board approval is needed. She quoted NY Dept. of State SEQR requirements and asked that, going forward, the proper communication and involvement of Town agencies be followed.

With regard to the Supervisor's query, Planning Director Kaufman stated that the reduced scope of the project, eliminating any stream disturbance and new plantings, would not require SEQR review.

Thomas Arnold and Norma Hill, Wampus Close residents, objected to the tree removal and the lack of involvement of Town Departments and Agencies other than the Parks and Recreation Board. It was recommended that the park plan should have been approved by the Town Board before the work was bid and the work was authorized. A Petition in opposition to the tree removal at the park on behalf of Wampus Close residents was presented for the record.

Barbara DiGiacinto suggested that when the Conservation Board meets to review the plan that residents of Wampus Close be invited to attend.

Councilman D'Angelo moved seconded by Councilman Schiliro to refer the Wampus Brook Park South development plan to the Planning Department for advice and input and to coordinate with appropriate Departments and Agencies and then report back to the Town Board.

The 2014 Preliminary Budget was marked as Exhibit "D" for the record.

Town Administrator Joan Goldberg provided a brief overview of the theory behind the 2014 Town budget. Ms. Goldberg said she spent the past year listening to residents' complaints and trying to respond to them. She said the 2014 budget included input from elected officials, Department Heads, employees and residents. She said the budget she is proposing includes funding to address road maintenance, brush clearing, and maintenance and repair of buildings and parks. The budget maintains two vacant laborer positions in the Highway Department and two vacant positions in the Parks Department. The addition of two new police officers has been included in an effort to reduce Police Department overtime which was \$800,000 in 2012. Ms. Goldberg said that in order to ensure that the Town can sustain its workforce into the future it was imperative that the Town reduce its expenses by creating a new level of benefits with lower time accruals, lower days off and a greater level of employee sharing of benefits costs. She said that the budget she is proposing will include an additional \$7.30 per month, or \$87 a year for the median home in North Castle.

Comptroller Faith Berland presented a summary of the budget, including the following points:

The Town has been working diligently to reduce spend in 2013 and develop a 2014 budget and tax rate increase which is as low as possible. The focus this year and next is operating efficiently, having transparency in our operations and providing high quality services at the lowest cost to the residents

There are three main parts to your tax bill.

- 1. The bulk of your taxes are based on the school district in which you reside.
- 2. County taxes, which are determined by Westchester County
- 3. Town taxes, which is summarized here.

The Town wide tax rate is made up of the General, Highway & Library Budgets, and is what the taxes raised through real property tax contributes to.

The General Fund is made up of the Town Board, Police Department, Parks and Recreation Department, Building Department, Town Clerk, Court, Finance, Supervisor, Administrator, Planning, Tax Receiver and Assessor.

The town tax rate does not include the Special Districts because those charges depend on the district you reside in. For example, if you have your own septic and well, you do not pay sewer and water taxes.

The total 2014 budget is \$29,886,189 up \$984,861 or 3.4% from 2013. General, Highway and Library represent \$25,167,520 or 84% of the total budget.

In 2011 Governor Cuomo established a tax levy limit or tax cap whereby the amount raised through property taxes is capped at 2% or the rate of inflation, whichever is less. The inflation factor for 2014 is 1.66% and therefore the tax cap has been reduced to 1.66%. The Office of the State Comptroller developed a property tax cap calculation used by each municipality in order to regulate the increase. The calculation takes into account adjustments including an adjustment for prior years if the entire tax cap limit was not levied which is how the calculation resulted in a 3.53% or \$736,245 increase for North Castle in 2014. North Castle increased the tax levy by 1.23% and 1.75% in 2012 and 2013 respectively.

The preliminary budget calls for a \$614,448 or 2.95% growth in taxes levied, which is \$121,797 under the tax cap.

Increases in expenses of approx. \$985k are due to:

- Increased Police expenses for: 2 new Police officers approx. \$100k each, 2 new cars total \$100k, and an increase in over-time expense \$50k,
- New equipment: A hybrid truck for the Building Department \$40k, a Truck with a plow \$60k and a snow tractor for Parks \$25k, a truck, crack sealer and claw for highway \$175k and a truck for \$28k \$28k
- Water expenses as a result of increased water sales and per-capita charges \$174k
- S2 plant upgrades including a rebuild of clarifier boxes and replacement of UV disinfection unit \$63k

These additional expenses were partially offset by:

- Reduced garbage expenses of \$56k
- A reduction to budgeted certs/scars

Revenue increased approximately \$400k from:

- Increased water sales in districts 4 and 2 and a projected increase in per-capita charges in district 1 \$200k
- Projected increase in camp revenue in line with 2013 actuals (\$74k),
- Revenue from Byram Hills School District for the new School Resource Officer (SRO) or Officer Bill as your children now know him. The school district will be paying half the fully loaded cost or \$69k
- New administrative Wetlands fee as result of the change in the Wetlands code to develop an administrative review process, the majority of which is paid to Kellard, \$30k
- \$20k increase in PILOT revenue as IJAN has cancelled their PILOT and Engel Berman's payments begin ramping up, and additional tax penalty revenue in line with actual revenue in the current year, \$25k.

Real Estate Taxes are calculated based on the General, Highway, and Library Fund expenses, revenue and fund balance. We take our expenses for these funds and subtract revenue and fund balance contributions to get to the money to be raised from real property taxes.

General, Highway and Library Expenses increased by 2.95% or \$721,575 year on year and Revenue increased by 3.18% or \$196,516.

Overall the money levied from real property taxes increased 3.02% or \$549,620

The tax rate is then calculated by taking the money raised from property taxes divided by the total assessed value. Assessed values have remained flat year on year.

The real property tax rate increased 2.98% or \$4.66.

Average tax rate increases:

5 years 3.28%,

10 years 4.63%

20 years 3.07%

Providing an example for homeowners, the Comptroller said the Town calculates the 2014 general town taxes by taking the assessed value of \$18,800 divided by \$1,000 and then multiplied by \$160.99, which is the tax rate in the 2014 preliminary budget. This equals \$3,027.

The difference in the general taxes versus last year is \$87.67 which is the dollar value of the increase on the median home's town taxes. This represents a 2.98% increase year on year.

Explaining how the Town generates funds outside of property taxes which includes:

• Our PILOTS (Payment of lieu of taxes) which represents revenue from agreements with a few large corporations in town (Special tax agreements) IBM, Swiss Re and Engel Berman

- Each municipality receives a share of the mortgage tax and sales tax collected by Westchester County.
- Department Income includes Town Clerk Fees, Recreation Fees, Rebillables (police special detail), and Cable Franchise Fees. (the largest slice)
- License and Permits are collected through the Building Department, town clerk's office and to a smaller extent from parks and recreation.
- In addition we generate revenue from Fines & Forfeitures associated with the courts, Interest Income based on investing of our funds and other revenue from state aid, Insurance Recoveries and other Miscellaneous Sources.

On the expenses side, personnel costs are 64% of the overall budget. The 2014 budget includes 2 additional full time staff (namely 2 new police officers) compared to the 2013 budget. However, none of the 8 budgeted new full time positions in 2013 were filled.

In 2013 we delivered services that residents have been requesting, namely road repairs, park maintenance and refurbishment, first class programing through the Library and Recreation Department along with beautification efforts. This targeted focus on operating efficiently, having transparency in our operations and providing high quality services at the lowest cost to the residents will continue into 2014.

Capital Improvement projects continue to be a focus in the 2014 budget with money allocated to road pavement, vehicle replacement, and Town-wide technology upgrades.

In summary, the preliminary budget is \$29,886,189. The proposed tax levy is 2.95% or \$614,448 which is \$121,797 under the cap.

The tax rate increase is 2.98% and results in an impact on the median home's general town taxes of \$87.67.

Susan Shimer, speaking as Chair of the Landmarks Preservation Committee, said she reviewed the proposed budget and could not find any response to the Committee's request for \$2,250 to create for an audio tour of the Historic District. Supervisor Arden confirmed that this amount was not included in the budget because some members of the Board thought the funds could be raised privately. Ms. Shimer said the Committee had tried to do this for a year before they made its request. In response to Ms. Shimer's query regarding the funds in the proposed budget for concerts in the park, Ms.Goldberg said there was \$20,000 for special projects which included the concerts in the parks and other events.

Shelia Tyler, CSEA Labor Relations Specialist, said it was important for the Town to purchase new equipment to keep residents safe and for the Town to have an inventory of the equipment it already has.

After all persons were heard who desired to be heard, Councilman D'Angelo moved, seconded by Councilman Schiliro, that the Public Hearing be adjourned at 8:39 p.m.

At 8:40 p.m. Supervisor Arden reconvened the Public Hearing, which was adjourned from November 6, 2013, at Town Hall, 15 Bedford Road, Armonk, New York, 10504, for the purpose of considering a local law to amend the Zoning Code of the Town of North Castle concerning three parcels of land located on Old Mount Kisco Road, Armonk, New York (Section 2, Block 12, Lot 2.-

1, 2.-2, and 3), with respect to the definition of senior housing and the calculation of affordable affirmatively furthering fair housing (AFFH) in the R-MF-SCH Zoning District, the mapping of the R-MF-SCH Zoning District to Petitioner's property, and establishment of bulk and area requirements.

A revised local law was received, since the November 6, 2013 meeting, amending Section 213-3 of the Town Code with the following definition of "Senior Citizen Housing":

"Housing limited in occupancy to persons who have attained the age of (a) 62 years or more on the date that they initially occupy the dwelling unit, as regulated by the Federal Fair Housing Act, or (b) 55 years or more on the date that they initially occupy the dwelling unit, as regulated by the Federal Fair Housing Act, to be determined by the Town Board on a case-by-case basis at the time of each zoning approval."

At 8:40 p.m. Supervisor Arden reconvened the Public Hearings which adjourned from November 6, 2013 in accordance with the Orders calling the Public Hearings, which follow at the end of these minutes, to consider the petition, map and plan in the matter of the extension of Sewer District No. 2, Old Mount Kisco Road (Section 108.01, Block 1, Lots 18, 19, 20, 21, 22, 23, 26, 27, 28, 29) and to consider the petition, map and plan in the matter of the extension of Water District No. 4, Old Mount Kisco Road, (Section 108.01, Block 1, Lots 27, 28, 29).

A letter from GHD Consulting Services, dated November 15, 2013, was received since the November 6, 2013 meeting and marked Exhibit "G" for the record.

Tony Veneziano, attorney for the applicant, Frank Madonna, Jr., spoke of the November 14, 2013 meeting, attended by Sal Misiti, Director of Water and Sewer Operations, Jan Salzman, Project Manager, GHD, and NYSDEC, to discuss the increase in flow capacity of Sewer District No. 2. Mr. Veneziano said the local law has been modified with regard to the definition of senior housing to provide for an age requirement of either age of 62 years or more, or age of 55 years or more.

Mr. Misiti reviewed the following points, detailed in the GHD letter, dated November 15, 2013, which summarized the meeting with NYSDEC to review the possibility of expanding flow capacity of the Sewer District No. 2 Wastewater Treatment Plant and associated modification to the plant SPDES (State Pollutant Discharge Elimination System) permit to increase flow.

- NYSDEC would not be opposed to modifying the permit in accordance with re-rated plant capacity.
- NYSDEC is pleased with the performance of the Town's wastewater treatment plant in terms of nitrogen removal. Mr. Misiti said the Town met the 2014 nitrogen discharge limits three years ago.
- If the Town wants to increase flow capacity, it has to demonstrate to NYSDEC that the current nitrogen limits can be maintained.
- With regard to the possibility of obtaining nitrogen "credits" for connecting currently unsewered properties, NYSDEC said it would require a re-opening of the Total Monitoring Discharge Limit (TMDL) and modification of the 2014 nitrogen limits which is unlikely to be accomplished in the near future.
- GHD is developing a pilot study to review increases to 600,000 gpd (0.6 mgd) and 700,000 gpd (0.7 mgd) to assist the Town in selecting the desired flow limit.
- Following the pilot study, GHD will develop an engineering report for submission to NYSDEC.

Mr. Misiti said the amount of flow for the applicant's project is not significant. He said it is for the Town Board to decide if it will require buy-in recapture fee for entry into sewer district based on the formula he developed and the calculations confirmed by GHD. The applicant should be advised of the requirements to upgrade the pump station.

In response to a query from Councilman Schiliro, Mr. Misiti said he would ask GHD about obtaining a benchmark at the stream near the applicant's site prior to the hookup of sewers.

In response to queries from Craig Useted regarding changes to the local law during the course of the public hearings, Director of Planning Adam Kaufman clarified that it was the recommendation of the Planning Board to include affordable affirmatively furthering fair housing (AFFH) units and this was not a new issue. Mr. Useted expressed his concerns with the screening of the property, the type of building being proposed, and rear setbacks of ten feet. In response to his queries, it was clarified that the market units would be taxed as fee simple and the AFFH units would be taxed based on the

price for which they could be sold. It was also clarified that not less than 10% of the units on any site in an R-MF-SCH District was required to be set aside as AFFH units. Mr. Veneziano said that they will work with the Planning Board regarding the rear setbacks.

In response to queries from Christine Eggleton regarding which of the 14 units would be AFFH units and how they will be administered, Town Attorney Baroni explained that the two AFFH units would be deed restricted, not aged restricted. Twenty per cent, or three if the 12 market units could be occupied by people under age 55; eighty percent, the remaining nine market units have to be age restricted.

In response to a query from John Diaconis regarding the income levels to qualify for a MIU unit as compared to an AFFH unit, Councilman Schiliro said it was approximately \$105,000 for a MIU as compared to \$85,000 for an AFFH.

In response to a comment from Susan Shimer that the local law should include in the definition of affordable affirmatively furthering fair housing the phase *as provided in the model ordinance*, Mr. Baroni said he agreed the law should be amended to include this language. In response to Ms. Shimer's comment that there is no criteria in the law regarding when an age 55 or age 62 minimum would be used, Mr. Baroni said this matter was reviewed and it was determined that this would be reviewed by the Town Board on a case-by-case basis at the time of each zoning approval.

In response to a query from Kyra Goldsmith to confirm that the rear of the proposed buildings would be facing her property on Old Mount Kisco Road and what the setback would be, Mr. Madonna said that the rear setbacks are averaging about 30 feet. Mr. Kaufman advised the Board that the minimum rear yard setback of 10 feet would apply to all senior floating zones if the proposed law is adopted as written.

Joseph DiMauro expressed his opposition to the project.

In response to a query from Mr. Baroni if the Town could build a well at the project location, Mr. Veneziano confirmed that the Town has the right to build it and the applicant provided the Town with an easement.

In response to a query from Councilman Cronin regarding the cost to hookup the eight properties to the sewer district, Mr. Madonna said it was approximately \$250,000.

After all persons were heard who desired to be heard, Councilman D'Angelo moved, seconded by Councilman DiDonato Roth, that the public hearings be closed at 9:25 p.m.

A Local Law to amend Chapter 213 of the Town of North Castle Town Code with respect to the R-MF-SCH Zoning District.

Section 1. Amend Section 213-3 of the Town of North Castle Town Code, Definitions, by amending the definition of "Senior Citizen Housing" to read as follows:

"Housing limited in occupancy to persons who have attained the age of (a) 62 years or more on the date that they initially occupy the dwelling unit, as regulated by the Federal Fair Housing Act, or (b) 55 years or more on the date that they initially occupy the dwelling unit, as regulated by the Federal Fair Housing Act, to be determined by the Town Board on a case-by-case basis at the time of each zoning approval."

Section 2. Amend Section 213-22.3(B)(5) by amending the first sentence thereof to read as follows:

"Not less than 10% of the units on any site in an R-MF-SCH District shall be set aside as affordable affirmatively furthering fair housing (AFFH), as defined in the Town's AFFH draft model ordinance.

Section 3. Amend Section 213-5 by amending the Town of North Castle Zoning Map to remove Section 2, Block 12, Lot 3 from both the R-1A and R-10 Zoning Districts and adding it to the R-MF-SCH Zoning District and further amending the Town of North Castle Zoning Map to remove Section 2, Block 12, Lots 2-1 and 2-2 from the R-10 Zoning District and adding said lots to the R-MF-SCH Zoning District and, in accordance with Section 213-22.3(B)(2) and Section 213-19 (Schedule of Residents District Regulations), establishing the following requirements for the foregoing parcels in conjunction with the rezoning of said parcels:

Maximum Floor Area Ratio:0.4Minimum Lot Area:3.0 acresMinimum Lot Frontage:750 feetMinimum Lot Width:500 feetMinimum Lot Depth:100 feet

Minimum Perimeter Front Yard: 20 feet Minimum Perimeter Side Yard: 20 feet Minimum Perimeter Rear Yard: 10 feet

Minimum Dwelling Unit Size: 1 bedroom unit – 800 s.f.

2 bedroom unit - 1,000 s.f.

Maximum Building Coverage: 20%

Section 4. Conflicting Standards.

Where the requirements of this Local Law impose a different restriction or requirement than imposed by other sections of the Code of the Town of North Castle, the Town Law of the State of New York, or other applicable rules or regulations, the requirements of this Local Law shall prevail.

Section 5. Severability.

The invalidity of any word, section, clause, paragraph, sentence, part or provision of this Local Law shall not affect the validity of any other part of this Local Law that can be given effect without such invalid part or parts.

Section 6. Effective Date.

This Local Law shall take effect immediately upon its adoption and filing with the Secretary of State.
