The minutes of the Public Hearing which commenced at 8:50 p.m. follow at the end of these minutes.

Doris (Dorrie) Finch Watson, Town Historian 1993-2014, passed away on December 30, 2014. In recognition, Town Clerk Curran described a video narrated by Dorrie, taped in October 2012, which has been retitled and is airing on NCTV and is posted on the Town website. In the video, Dorrie describes the five North Castle Historic Sites that were officially marked in 1976:

- Middle Patent Rural Cemetery, Banksville
- Historic Smith's Tavern, Armonk
- Maj. John Andre's Containment at Wrights Mill, Mile Square, Armonk
- Miller Hill Revolutionary War Battle Ground, North White Plains
- The Elijah Miller House, North White Plains

Ms. Curran read the closing slide of the video:

The Town of North Castle is indebted to Dorrie for:

Serving as Town Historian since 1993, helping to found The North Castle Historical Society, nurturing the Banksville Community House, administrating the Middle Patent Rural Cemetery, chairing the Elijah Miller House Committee, helping to found Friends of Miller House/Washington's Headquarters, serving on the Landmarks Preservation Committee and the Ethics Board, and for most competently and willingly sharing her knowledge of North Castle history with us. She is missed.

Councilman DiGiacinto moved, seconded by Councilman Reiter, receipt of notification of withdrawal of Petition for a zone text amendment from Breezemont Day Camp.

Vote: Unanimous

Councilman DiGiacinto moved, seconded by Councilman Reiter, receipt of letter from Rod Christie, Executive Director, Mianus River Gorge, noting appreciation to the Town Board, the Open Space Committee and the Conservation Board for support and collaboration regarding the purchase of the Levene Property and Conservation Easement to the Town.

Vote: Unanimous

Councilman Reiter moved, seconded by Councilman D'Angelo, receipt of a letter from the NYS Department of Transportation (DOT) regarding the traffic signal warrant analysis provided by John Meyer Consulting for the intersection of Route 22 and Cox Avenue. Based on the analysis, DOT review of crash history, and existing conditions at the intersection, NYS DOT determined that a traffic signal should not be installed at the intersection.

Vote: Unanimous

Councilman Reiter moved, seconded by Councilman DiGiacinto, receipt and ratification of work performed by Kellard Sessions for design of new sidewalks, and design, preparation and evaluation of bid documents. The following is an excerpt from the Kellard Sessions letter dated January 5, 2015:

This work was performed under verbal authorization from the Town. A contract has since been awarded to Vernon Hills Contracting Corp. to repair deteriorated sidewalks and construct new sidewalks and handicap ramps on Bedford Road from the intersection of Maple Avenue to the intersection of MacDonald Avenue, Maple Avenue in front of Hergenhan Recreation Center, the corner of Bedford Road and Main Street, the North Castle Annex Building, North Castle Building Department, a new stone paver sidewalk in front of the North Castle Library along Whippoorwill Road East and new concrete steps at the North Castle Police Station.

To date, Kellard Sessions Consulting has billed the Town \$10,385. This fee includes all engineering services required for the design and preparation of bid documents, bid services and evaluation and contract recommendation. Fees for providing construction services shall be billed on a Time and Materials (T&M) basis, with an estimated cost of \$6,000.

Vote: Unanimous

With regard to the Gazebo reconstruction design in Wampus Brook Park, Architect John Sullivan presented options for handicapped accessibility of a ramp design versus a mechanical lift. He said both options have drawbacks as a ramp can be an attraction for skateboarding and some type of chain to prevent access might be warranted. A mechanical lift would require a key or password, effectively eliminating spontaneous access to the gazebo for someone with a disability. Supervisor Schiliro stated that he wants all citizens to have the same ability to use the gazebo. If Town employees or the Police Department have to be contacted to operate a lift or open the ramp, that is not equal access. Mr. Sullivan said he will revisit options based on this direction.

Regarding timing of construction and when the Gazebo might be completed, Councilman D'Angelo said the Gazebo does not have to be finished by June, but there should not be an active construction site in Wampus Brook Park in early June when the Fol de Rol will take place.

The appointment of Special Counsel to advise the Town Board regarding disciplinary hearing concerning employee number 3257 was tabled.

Town Attorney Roland Baroni reiterated that the alternate member would only be able to be used in a very limited circumstance where there is a conflict; the alternate cannot be used when a member is simply unavailable for a meeting

Supervisor Schiliro said his concern regarding the continuity of an application was answered by the Chair of the Zoning Board of Appeals who said that it is rare when a decision regarding an application goes beyond one meeting.

The Board agreed that the term of the alternate position would be two years.

After all persons were heard who desired to be heard, Councilman D'Angelo moved, seconded by Councilman Reiter, that the Public Hearing be closed at 8:53 p.m.

TOWN OF NORTH CASTLE

Local Law No. 1 of the Year 2015 Adopted January 14, 2015

A Local Law to amend the Code of the Town of North Castle to amend Chapter 213 entitled **ZONING**.

Be It Enacted by the Town Board of the Town of North Castle as follows:

- 1. Section 213-65 <u>Board of Appeals</u> Subsection A. <u>Organization</u> is hereby amended to read as follows:
 - 1. The Board of Appeals, as heretofore established by the Town Board, is hereby maintained.
 - 2. Alternate Members The Town Board hereby establishes alternate Zoning Board of Appeals positions for purposes of substituting for a member in the event such member is unable to participate because of a conflict of interest. Alternate members of the Zoning Board of Appeals shall be appointed by resolution of the Town Board for terms established by the Town Board.
 - 3. The chairperson of the Zoning Board of Appeals may designate an

alternate member to substitute for a member when such member is unable to participate because of a conflict of interest on an application or matter before the Board. When so designated, the alternate member shall possess all the powers and responsibilities of such member of the Board. Such designation shall be entered into the minutes of the initial Zoning Board of Appeals meeting at which the substitution is made.

- 4. All provisions of this section relating to Zoning Board of Appeals member training and continuing education, attendance, conflict of interest, compensation, eligibility, vacancy in office, removal, and service on other boards, shall also apply to alternate members.
- 2. <u>Effective Date</u>: This Local Law shall be effective immediately upon filing of same with the Secretary of State of the State of New York.
