With regard to the Madonna Wampus Mills Project at 805 - 809 Route 128, Kory Salomone, Veneziano & Associates, appeared before the Board with his client Frank Madonna in connection with the zoning petition and sewer district extension petition submitted in September 2015. Mr. Salomone described the subject property of two adjacent parcels, lots 6 and 7, of approximately 10 acres and currently zoned as R-2A, two acre zoning. The zoning petition requests that the property be rezoned to R-1A, one acre zoning. The petition to extend Sewer District No. 2 includes the two parcels as well as eight additional parcels on the second half of Old Mt. Kisco Road. Mr. Salomone noted that Mr. Madonna's age-restricted project on Old Mt. Kisco Road includes the extension of the District to the first half of Old Mt. Kisco Road. He said the Town Board referred the Wampus Mills project to the Planning Board which adopted a positive recommendation (5-0) in favor of the rezoning in November 2015.

In response to queries from the Board, Mr. Salomone confirmed that the plan for the Wampus Mills Project is to develop six units and four units can be built as of right under the existing zoning.

In response to queries from Councilman D'Angelo, Sal Misiti, Director of Water and Sewer Operations, said the draft sewer capacity report is expected in a few weeks and suggested that when the report is finalized a Work Session be held for the engineers to present the report with the options requested by the Board. Mr. Misiti said that the six new units being proposed were not included in the original allocation for the sewer extension to all lots on Old Mt. Kisco Road as included in the first Sewer Task Force Study and in the original expansion of the sewer plant. With regard to the sewer extension on Old Mt. Kisco Road, Mr. Misiti said everyone concerned needs to know exactly what is going to be done regarding the individual home connections and this should be detailed for the residents.

In response to queries from Councilman DiGiacinto regarding protecting the subject property from becoming a larger subdivision if the zoning were amended, and from Supervisor Schiliro if there could be a deed restriction to ensure a maximum density of six units, Director of Planning Adam Kaufman said this could be done.

Councilman DiGiacinto expressed concerns regarding comments from the Planning Board regarding the proposed sewer use and Kellard Sessions regarding stormwater mitigation and sewer capacity. Ms. DiGiacinto said she would like written information for the residents of Old Mt. Kisco Road regarding the sewer connections to their homes. Town Attorney Roland Baroni said the map, plan and report would be the subject of a public hearing on the sewer district extension. Mr. Kaufman said that the comments from the Planning Board and Kellard Sessions were technical subdivision comments separate from the zoning request.

Mr. Baroni said two public hearings are required, one regarding the zoning and the other regarding the amendment to the Comprehensive Plan Map, which could be held at the same meeting. He added that a public hearing regarding the sewer district extension could be held soon after the

Town Board Minutes January 13, 2016 hearing on the zoning, and added that a proceeding for the extension should not begin until it is certain that the zoning will be put in place.

RESOLUTION AMENDING RESOLUTION DATED AUGUST 5, 2015

A Resolution Making Certain Determinations In Relation to the Proposed Establishment of Long Pond Park District in the Town of North Castle Westchester County, New York
