NOTICE IS HEREBY GIVEN THAT the North Castle Town Board will hold a Public Hearing on July 14, 2021, at 7:30 PM, or as soon thereafter as practical, at Town Hall, 15 Bedford Road, Armonk, NY 10504, to consider a Local Law to amend the Code of the Town of North Castle, Chapter 325 entitled "Vehicles and Traffic", Section 325-55 Schedule XIII "No Parking Any Time" with regard to portions of Mianus River Road and Old Orchard Street.

The proposed local law is available in the Town Clerk's office during regular business hours and on the Town website. ALL PERSONS HAVING AN INTEREST IN THE MATTER ARE INVITED TO ATTEND AND BE HEARD.

Memo from Police Chief Peter Simonsen, dated April 23, 2021, and memos from Sergeant Thomas McCormack, dated November 9, 2020 and January 30, 2021, were marked Exhibit "D" for the record.

The Town Clerk noted there was a proposed Local Law for consideration.

Sergeant Thomas McCormack appeared before the Board and reviewed parking concerns on Mianus River Road, in the area of the Mianus River Preserve, and on Old Orchard Street in the area of the Westchester County Cranberry Lake Preserve, as detailed in his memos dated November 9, 2020 and January 30, 2021.

Budd Veverka, Director of Land Management for the Mianus River Gorge Preserve, expressed support of the proposed no parking in the area of the Mianus River Preserve.

Councilman Hussain asked if all parking spaces within Cranberry Lake Preserve are full when visitors are parked on Old Orchard Street, and if additional signage regarding parking should be provided directing visitors to additional parking areas within the Preserve. Sergeant McCormack said he believed the County is working to delineate the parking spaces and signage to additional parking. Councilman Hussain also recommended additional signage to inform visitors of other parks and recreation facilities within North Castle.

Supervisor Schiliro expressed support of marking parking spaces to provide for more parking, and enhancing signage to inform visitors of additional off street parking.

After all persons were heard who desired to be heard, Councilman Reiter moved, seconded by Councilman Berra, that the Public Hearing be closed at 8:40 p.m.

TOWN OF NORTH CASTLE

Local Law No. 5 for the Year 2021
Adopted July 14, 2021

A Local Law to amend Chapter 325 of the Code of the Town of North Castle entitled Vehicles and Traffic.

Be It Enacted by the Town Board of the Town of North Castle as follows:

Section 3. Chapter 325-55 Schedule XIII: No Parking Any Time is hereby amended to add the following:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Old Orchard Street	North	From its intersection with Route 22 east to the Harrison Town line
Old Orchard Street	South	70 feet East of its intersection with Route 22 to the Harrison Town Line
<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Mianus River Road	Both	For a distance of 1,102 feet south of the Bedford Town Line

Section 4. Effective Date: this Local Law shall be effective immediately upon filing of same with the Secretary of State of the State of New York.
