Police Chief Peter Simonsen indicated that safety concerns at the intersection of School Street and Cox Avenue, Armonk were raised by members of the public and the Town commissioned Hardesty & Hanover to perform a traffic study of the intersection. Based on the results of that study, Chief Simonsen recommended the establishment of a "T" intersection at the location and the installation of a stop sign at the intersection for motorists traveling west on Cox Avenue.

In a response to the concerns of resident Fatmir Pushka regarding the positioning of the stop sign on Cox Avenue, Chief Simonsen said he would work with Mr. Pushka to install the sign at a suitable location.

Residents Alfio Della Vecchia and Serah Zeppieri stated their support of the changes to the intersection and thanked the Police Department and Town Board for addressing their concerns.

The Board members shared their support for the legislation and proposed changes to the intersection; and Supervisor Schiliro, Councilman DiGiacinto, and Chief Simonsen indicated that this was a collaborative effort of the community and praised the involvement of the residents.

After all persons were heard who desired to be heard, Councilman Hussain moved, seconded by Councilman Milim, that the Public Hearing be closed at 8:44 p.m.

## Local Law No. 8 for the Year 2022 Adopted July 27, 2022

A Local Law to amend Chapter 325 of the Code of the Town of North Castle entitled Vehicles and Traffic.

Be It Enacted by the Town Board of the Town of North Castle as follows:

<u>Chapter 325-49 Schedule VII: Stop Intersections</u> is hereby amended to add the following:

<u>Stop Sign on</u> <u>Direction of Travel</u> <u>At Intersection of</u>

Cox Avenue West School Street

<u>Effective Date:</u> This Local Law shall be effective immediately upon filing of same with the Secretary of State of the State of New York.
