## Dated July 27, 2022 Establishing 16 Nethermont Avenue in North White Plains as an Open Space Parcel, Section 122.16, Block 4, Lot 10, on the Tax Assessment Map of the Town of North Castle

**WHEREAS**, Mount Misery, of which 16 Nethermont Avenue is a part, is located on the crest of Nethermont Avenue and is a historically important hill that served as a strategic defensive post during the Battle of White Plains in 1776; and

**WHEREAS**, 16 Nethermont Avenue is owned by the Town of North Castle, the parcel having been included in an In Rem Foreclosure in 2014; and

**WHEREAS**, previous town boards have declined to sell the parcel due to its historical significance; and

**WHEREAS**, the present Town Board desires to preserve 16 Nethermont Avenue in perpetuity by declaring it an open space parcel; and
