Town Attorney Roland Baroni explained that the proposed local law will eliminate the Middle Income Unit Eligibility Priority List from the North Castle Town Code. The Town Attorney has brought to the Town's attention the existence of antidiscrimination lawsuits in Westchester County municipalities regarding the resident preference provisions in their Middle Income Unit laws. Enacting this law is an effort to prevent future potential litigation against the Town of North Castle. As a result of the adoption of the legislation, MIU units would be awarded via a lottery drawing in the same manner as Affirmatively Furthering Fair Housing (AFFH) units in Westchester County.

After all persons were heard who desired to be heard, Councilman D'Angelo moved, seconded by Councilman Reiter, that the Public Hearing be closed at 8:40 p.m.

Local Law No. 3 for the Year 2018 Adopted April 25, 2108

A Local Law to amend Section 355-24(12)(d) of the Town of North Castle Zoning Code to remove the Middle Income Unit Eligibility Priority List.

Section 1. Amend Section 355-24(12)(d) as follows:

- (d) Unit sales; residency requirement.
 - [1] Candidates for the purchase of an MIU shall be selected by lottery from a pool of applicants submitted to the North Castle Housing Board.
