ORDER CALLING PUBLIC HEARING

WHEREAS, a petition, a map and plan have been prepared for BRYNWOOD PARTNERS LLC in such manner and in such detail as has heretofore been determined by the Town Board relating to the extension of Water District No. 2, and

WHEREAS, said petition, map and plan have been prepared by a competent engineer showing the boundaries of the proposed extension and a general plan of the water system connection, and
