## PUBLIC HEARING November 4, 2020

At 8:05 p.m. Supervisor Schiliro stated that a Public Hearing would be held in accordance with the Order calling the Public Hearing which is attached to the end of these minutes to consider the petition, map and plan in the matter of the extension of Water District No. 7, to include 150 Bedford Road, Section 108.03, Block 1, Lot 40.

Proposed Resolution for adoption.

Mr. Hollis and Paul Sysak, of JMC Planning, Engineering, Landscape Architecture & Land Surveying, PLLC, engineer for the applicant, appeared before the Board via web conference.

Supervisor Schiliro noted that there is an existing water main on the street of the subject property.

Referencing his memo dated October 6, 2020, Mr. Misiti noted that no infrastructure extension is involved with the property coming into the Water District and that the property owner is responsible for their own service connections. He said he has been in communication with the applicant's engineer.

Mr. Hollis described the subject property, as detailed in the Petition. He said that the combined water usage for the both residential and office use is projected to be 325 gallons per day.

After all persons were heard who desired to be heard, Councilman Berra moved, seconded by Councilman DiGiacinto, that the Public Hearing be closed at 8:10 p.m.
